YALE, SFI / 耶鲁大学,可持续金融学院

凯利·克洛辛斯基(Cary Krosinsky)是可持续金融领域全球顶级专家,是可持续金融学院(SFI – Sustainable Finance Institute, http://sfini.org)的创始人之一。持续金融学院是一家总部设在纽约的全球性教育、咨询与基金管理顾问机构。

凯利本人是一位著名的作家、教育家、高级顾问和企业家,他专注于投资可持续性和企业可持续性发展的策略研究。

凯利在众多国际机构和政府项目中担任总策划、顾问,包括:

- 另一本专著《Sustainable Investing: Revolutions in Theory and Practice》 (路特里奇出版社, 2017),由中国证监会中证金融研究院马险峰院 长等翻译,中国金融出版社于 2018 年 5 月出版发行(中文书名《三优 投资:投资理论与实践的一场革命》)。此书是全球众多商学院和经 济学院"可持续投资"课程的标准教材。
- 凯利的第五本书《Sustainable Innovation and Impact 可持续创新与影响》于 2018 年 6 月出版,此书提供了许多应对当前快速变化时代的投资策略的全球真实案例。

- Taught or advised in recent years with the University of Cambridge, KPMG, Kering and BlueSky Investment Management.
- Co-founder and Director of the Carbon Tracker Initiative and Real Impact Tracker, Principal at NPV Associates and Editor of the Journal of Environmental Investing (JEI).

- Lecturer on Corporate and Investment Sustainability Strategy at the University of Maryland's Smith School of Business
- Adviser to Columbia University's Earth Institute, where he helped lead and design the RFK Sustainable Investing Certificate Program helping investment professionals representing \$15T of assets develop and implement actionable strategies
- Guest professor for University of Edinburgh on sustainable finance
- Lecturer of Concordia University in Montreal

His books on sustainable finance inclues:

This book is now widely adopted by global finance majors as standard textbook.

- Latest book is Sustainable Real Estate: Multidisciplinary Approaches to an Evolving System.

His ongoing research includes establishing new disciplines on climate risk reporting, on Value Drivers and Systems Finance.

海闻, 男, 浙江杭州人, 1952 年 8 月出生。现任北京大学校务委员会副主任、北京大学汇丰商学院院长。北京大学中国经济研究中心联合创始人之一, 北京大学国家发展研究院(前身北京大学中国经济研究中心)教授, 曾任北京大学副校长兼北京大学深圳研究生院院长。

海闻教授 1982 年毕业于北京大学经济系,获经济学学士。1983 年毕业于美国长滩加州州立大学,获经济学硕士学位。1991 年毕业于美国戴维斯加州大学经济系,获经济学硕士和博士学位。海闻教授的主要教学及研究领域为国际经济学(贸易与金融)、发展经济学和转型经济学。



BA SHUSONG 巴曙松 PEKING UNIVERSITY HSBC BUSINESS SCHOOL 北京 大学汇丰商学院

巴曙松教授,中国银行业协会首席经济学家,香港交易所董事总经理、首席中国经济学家,北京大学汇丰金融研究院执行院长,北京大学汇丰商学院金融学教授,博士生导师。

他还兼任香港特别行政区政府经济发展委员会委员,中国宏观经济学会副秘书长、商务部经贸政策谘询委员会委员、中国银监会中国银行业实施巴塞尔新资本协议专家指导委员会委员、中国证监会并购重组专家谘询委员会委员、中国"十三五"国家发展规划专家委员会委员等。

巴教授乃中国国务院特殊津贴专家,先后担任中国银行杭州市分行副行长、中银香港助理总经理、中国证券业协会发展战略委员会主任、国务院发展研究中心金融研究所副所长等职务,曾在北京大学中国经济研究中心从事博士后研究,并曾担任国务院发展研究中心"国际经济金融结构"基础领域首席专家,以及在哥伦比亚大学商学院担任高级访问学者。

巴教授多次以金融专家身份参加中国金融领域的决策者主持召开的专家座谈会;先后在不同类型的金融机构担任管理职务,是同时熟悉中国金融市场实际业务运作、金融政策制定以及金融理论研究进展的金融专家。主要著作有:《巴塞尔新资本协议研究》、《金融危机中的巴塞尔新资本协议:挑战与改进》、《巴塞尔资本协议 III 研究》、《巴塞尔 III 与金融监管大变革》、《中国资产管理行业发展报告》年度报告等。巴教授曾获全球青年领袖奖(世界经济论坛,2009)。



JOHN KERRY 约翰·克里 USA 前国务卿

约翰·福布斯·克里(生于 1943 年 12 月 11 日)是美国第 68 任国务卿 (2013-2017 年)。担任国务卿之前(1985-2013)为代表马萨诸塞州的联邦 参议员。他是 2004 年美国总统大选候选人。

克里出生于科罗拉多州奥罗拉。1966年毕业于耶鲁大学, 获政治学学士学位。

克里先生长期致力于全球环境保护的努力。在 2016 年 4 月 22 日地球日当天,他抱着孙女,代表美国与 170 多个国家和地区的领导人,在纽约联合国总部签署了《巴黎气候协定》,承诺讲全球气温升高幅度控制在 2°C以内。

2016年11月11日,克里成为迄今为止访问南极洲的第一位国务卿和最高级别的美国官员。 克里在麦克默多南极观测站与研究人员连续进行了两天的气候变化科学讨论。

1994年,克里反对继续为 Integral Fast Reactor 反应堆项目提供资金,导致该项目被迫终止。 然而,鉴于对气候变化越来越多的关注,2017年克里改变了他对核电的立场,并表示"鉴于我们今天面临诸多的环境和气候挑战,并考虑到第四代核能技术的先进性,我们似乎没有更好的其他选择:因为我们必须实现零排放。"

John Forbes Kerry (born December 11, 1943) is an American politician who served as the 68th United States Secretary of State from 2013 to 2017. A member of the Democratic Party, he previously served as a United States Senator from Massachusetts from 1985 until 2013. He was the Democratic nominee in the 2004 presidential election.

Kerry was born in Aurora, Colorado, and attended boarding school in Massachusetts and New Hampshire. He graduated from Yale University in 1966 with a major in political science.

Kerry has had a long-standing concern with environmentalism as a global issue. On April 22nd, 2016, he signed the Paris Climate Accords at the United Nations in New York, with his granddaughter in his arms. More than 170 countries signed the Paris Climate Accords on the Earth Day, trying to keep the national average temperature from rising 2 degrees Celsius or more.

On November 11, 2016, Kerry became the first Secretary of State and highestranking U.S. official to date to visit Antarctica. Kerry spent two days on the continent meeting with researchers and staying overnight at McMurdo Station.

In 1994, Kerry led opposition to continued funding for the Integral Fast Reactor, which resulting in the end of funding for the project. However, in light of increasing concerns regarding climate change, in 2017 Kerry reversed his position on nuclear power, saying "Given this challenge we face today, and given the progress of fourth generation nuclear: go for it. No other alternative, zero emissions."



SIMON ZADEK 西蒙·扎德克 UN ENVIRONMENT / 联合国环境署,主任

西蒙是联合国环境署可持续金融系统设计调查的联合主任。

他目前还是新加坡管理大学的客座教授,国际可持续发展研究所的高级研究员,以及社会商业学院的杰出高级研究员,并且最近担任北京清华大学经济与管理学院的访问学者。他还曾担任哈佛大学肯尼迪政府学院的高级访问学者。

他是领先的可持续发展投资基金世代投资管理公司(Generation Investment Management)的顾问委员会成员。他创立并担任国际智库 AccountAbility 的首席执行官。在此之前担任新经济基金会的发展总监,道德贸易倡议的创始主席和全球报告倡议组织的创始指导委员。

Simon 发表了大量文章: 他的书《The Civil Corporation》被授予管理科学院 (Academy of Management)的最佳*管理学的社会问题*专著。他的哈佛商业评论文章"企业责任之路"被广泛引用。

他曾就可持续发展问题为全球公司提供建议。最近刚刚离开已经工作和生活 了数年的中国。

Simon is co-Director of the UN Environment's Inquiry into the Design of a Sustainable Financial System.

He is also currently Visiting Professor at Singapore Management University, a Senior Fellow at the International Institute of Sustainable Development, and Distinguished Senior Fellow of the Academy of Business in Society, and was until recently a Visiting Scholar at Tsinghua School of Economics and Management in Beijing, and was Senior Visiting Fellow at Harvard's J F Kennedy School of Government.

He is on the Advisory Board of the leading sustainability investment fund, Generation Investment Management. He founded and was until 2009 Chief Executive of the international think tank, AccountAbility, and before that Development Director of the New Economics Foundation, founding Chair of the Ethical Trading Initiative and on the founding Steering Committee of the Global Reporting Initiative.

Simon publishes extensively: his book, 'The Civil Corporation', was awarded the Academy of Management's prestigious Best Book on Social Issues in Management, and his Harvard Business Review article, 'Paths to Corporate Responsibility' is widely used as a reference point in understanding emergent sustainability strategies.

He had advised companies worldwide on sustainability issues, and until recently lived in China.



CHANG SUN 孙强

TPG 德太集团

孙强在香港和北京两地全面负责 TPG(德太集团) 在中国的投资业务,包括 其亚洲基金、增长基金以及社会效益基金 The Rise Fund。

孙强有 25 年的中国市场投资经验。他曾担任全球私募股权投资公司华平投资集团 (Warburg Pincus)的亚太区主席,早期创建了其中国业务,并率领其登上中国私募行业的领先地位。

孙强一直活跃于中国的投资界,他创办了中华股权投资协会(CVCA)和中华房地产开发投资商会(CREDIA),如今仍分别担任这两家机构的荣誉理事长和执行副理事长。孙强还是沃顿商学院亚洲董事会校董、沃顿商学院劳德学院的校董、以及大自然保护协会亚太协会的理事。

孙强曾于 2015 年创建黑土地集团,并担任董事长,主要从事大米和马铃薯 生产。

TPG 较早进入中国市场,投资领域覆盖金融服务、医疗保健、消费零售和科技、传媒以及科技等多个行业。

Mr. Chang Sun is a Managing Partner of TPG. He oversees TPG's investment activities in China across TPG Capital Asia, TPG Growth, and The Rise Fund.

Chang Sun has over 25 years of experience investing in China, and has been regarded as one of the pioneers of the nation's private equity industry. Chang Sun was the Chairman, Asia Pacific, at Warburg Pincus, where he was responsible for starting the firm's China business and building it into a leading private equity franchise.

Throughout his career, Chang Sun has been an integral part of China's investment community. He founded two industry trade organizations – the China Venture Capital and Private Equity Association (CVCA) and the China Real Estate Developers and Investors' Association (CREDIA) – where he currently serves as Honorary Chairman and Executive Vice Chairman, respectively. Chang Sun is a member of the Asia Executive Board of the Wharton School, a member of the Board of Governors at the Lauder Institute of the Wharton School, and a member of the Asia Pacific Council of the Nature Conservancy.

Chang Sun was most recently the Founder and Managing Partner of Black Soil Group Ltd, an impact investing firm he founded in 2015.

Chang Sun joins TPG's seasoned, regional investment team which has been actively investing in Asia for more than 20 years. The firm is one of the earliest global private equity investors in China and has made pioneering investments in numerous companies across a wide range of industries, including financial services, healthcare, retail, and TMT (technology, media, and telecommunications).



HANNAH ROUTH 汉娜·萝丝 DELOITTE, HKGFA/德勤,香港绿色金融协会

Hannah 是德勤的合伙人,领导可持续发展和气候变化咨询业务。她也是香港绿色金融协会的特别顾问。Hannah 是一位绿色金融和气候变化投资专家,在该领域拥有超过 20 年的经验,其中十年是在中国。

除了德勤的角色, Hannah 还担任以下职位:

- 香港绿色金融协会,特别顾问。
- 香港绿色金融专责小组,联合创始人
- 金融服务发展委员会(FSDC),绿色金融和 ESG 工作组
- 英国商务部能源与环境委员会副主席。

Hannah 为各种类型的政府、机构和企业提供有关投资和业务运营中的环境,社会和治理(ESG)风险的建议。她的工作涉及 ESG 整合、气候变化影响的缓解对策、负责任的投资和绿色金融,以及可持续发展战略与实施。她最初于 2007 年来到中国,在北京成立气候变化和碳交易咨询公司,为中国,美国和英国政府以及联合国机构的相关项目提供有关气候政策和清洁能源项目融资的建议。在此之前,她在南部非洲经营一家非政府组织,资助和实施可再生能源项目。

她的背景是建筑环境设计和可再生能源整合。 Hannah 拥有曼彻斯特大学的两个硕士学位,一个是物理学,另一个是污染和环境控制。她的母语是英语,会说流利的法语,了解斯瓦蒂语和普通话。

Hannah is a partner with Deloitte and leads the Sustainability and Climate Change advisory practice. She is also the special advisor to the Hong Kong Green Finance Association. She is a green finance and climate change specialist with over 20 years of experience in the field, of which the last ten are in China.

As well as her Deloitte role, Hannah holds the following industry positions:

- Hong Kong Green Finance Association, special adviser.
- Hong Kong Green Finance Task Force, co-founder.

- Financial Services Development Council (FSDC), green finance and ESG working groups
- British Chamber of Commerce energy & environment committee, vice-chair.

Hannah advises governments, organizations and companies across all sectors on environmental, social and governance (ESG) risk within investments and business operations. Her work covers ESG integration, climate change policy and mitigation, responsible investment and green finance, as well as sustainability strategy and implementation. She originally came to China in 2007 to set up a climate change and carbon trading advisory company in Beijing, where she led various projects to advise the Chinese, US and UK governments, as well as UN agencies, on climate policy and clean energy project finance. Prior to that she ran an NGO in southern Africa financing and implementing renewable energy projects. Her longer term background is in environmental building design and renewable energy integration.

Hannah holds two masters degrees from the University of Manchester, the first in Physics and the second in Pollution and Environmental Control. Her mother tongue is English and she speaks fluent French, passable SiSwati and basic Mandarin.

徐林先生于 2012 年 10 月任职国家发改委发展规划司司长,参与中国经济社会发展多个五年计划的编制,参与区域发展规划和区域政策,国家产业政策的制定,参与中国加入世界贸易组织的谈判,专门负责工业补贴的谈判。此前任职国家发改委财金司司长(2006-2012),国家发改委发展规划司副司长(2002-2006)。徐林先生持有南开大学经济学硕士学位,并获美国政府汉弗莱奖学金和新加坡政府李光耀奖学金资助,分别在美国美利坚大学,新加坡国立大学和哈佛大学肯尼迪政府学院学习,获得公共管理硕士学位。

Mr. Lin Xu served as Director of the Development and Planning Department of the National Development and Reform Commission (NDRC) from October 2012. He participated in the preparation of several five-year plans for China's economic and social development, participated in regional development planning and regional policies, and formulated national industrial policies. He was a major participant in China's negotiations to join the World Trade Organization, specializing in the negotiation of industrial subsidies. Previously Mr. Xu served as Director of the Financial Planning Department from 2006-2012 and Deputy Director of the Development and Planning Department of the NDRC from 2002-2006.

Mr. Xu holds a Master's Degree in Economics from Nankai University and was awarded a U.S. government Humphrey Scholarship and Singaporean government Lee Kuan Yew Scholarship. He has also studied at American University, National University of Singapore, and the Kennedy School of Government at Harvard University, where he obtained a Master's Degree in Public Administration.

Karine is Senior Advisor to the Asia Investment team and is a board member of a number of East Capital entities in Luxembourg. She is a French trade counsellor, Vice Chairman of the Swedish Chamber of Commerce in Hong Kong and board member of the European Chamber of Commerce in Hong Kong.

Prior to East Capital, Karine was responsible for Eastbridge Bank in Moscow, and between 1994 and 1995 she was a consultant for various financing projects in the Volga region in Russia, and responsible for a credit risk training programme at NBD Bank in Russian Nizhny-Novgorod. Karine has a degree from EM Lyon in France and a post-graduate degree from Institut d'Etudes Politiques in Paris. Karine also studied at the Moscow Financial Academy and the Swedish School of Economics and Business Administration in Helsinki. She is fluent in French, English, Russian, Swedish and is learning Chinese.
