ORDINANCE NO. 23-01

AN ORDINANCE AMENDING PARK CITY ZONING ORDINANCE, REZONING PROPERTY LOCATED AT 50 TISDALE STREET CONTAINING 2.5 TOTAL ACRES MORE OR LESS, FROM R-2 (MULTI-FAMILY RESIDENTIAL) TO NB (NEIGHBORHOOD BUSINESS DISTRICT).

IT APPEARING THAT:

- 1. Charlotte Vasquez, applicant and owner has requested a zoning change for the property located at 50 Tisdale St., containing 2.5 acres, more or less, a schematic drawing of said property subject to rezoning is attached hereto as Exhibit "A" and incorporated herein by reference.
- A trial-type due process hearing concerning said property zoning change was held on October 17, 2022 at 7:00 P.M., by the Joint City-County Planning Commission, resulting in the recommendation by the Commission that the property hereinafter described be rezoned from R-2 (Multi Family Residential District to NB (Neighborhood Business District).
- 3. Copies of the finding and recommendations of the Joint City-County Planning and Zoning Commission have been forwarded to the Park City City Commission, which are hereby adopted by the Park City City Commission, and are attached to this Ordinance as Exhibit "B" and incorporated herein by reference.

NOW, THEREFORE, BE IT ORDAINED by the City of Park City as follows:

SECTION 1. The findings and recommendations of the Joint City-County Planning Commission, copies of which are attached hereto as Exhibit "B", are hereby approved in all respects.

SECTION 2. The property located at 50 Tisdale St., Park City, Kentucky, containing 2.5 acres, more or less, be rezoned from R-2 (Multi-Family Residential District) to NB (Neighborhood Business District) classification, the real property covered by this Ordinance being more particularly described in Exhibit "A" and incorporated herein by reference.

SECTION 3. The Mayor of Park City is empowered and directed to complete any documents on behalf of the City of Park City, Kentucky necessary to implement this action.

CITY OF PARK CITY RESOLUTION NO. 04 - 23 A RESOLUTION ADOPTING THE BARREN COUNTY EMERGENCY OPERATIONS PLAN (EOP)

THAT WHEREAS, KRS 39B .010(1), KRS 39B .030(3), KRS 39C .050(3), and applicable Kentucky Administrative Regulations requires the development and maintenance of a local Emergency Operation Plan which sets forth the local government organizational structure, policies, procedures, and guidelines for the management and coordination of all disaster and emergency responses in Barren County and its cities; and

WHEREAS, KRS 39B .030(3), KRS 39B .060(2), and KRS 39C .050(3), applicable Kentucky Administrative Regulations, and planning guidance issued by the Kentucky Division of Emergency Management require local Emergency Operations Plan be officially approved and adopted by signed orders of the County Judge Executive or Mayor; and

WHEREAS, the Director of the Barren County Office of Emergency Management has submitted the Barren County Emergency Operations Plan to the Mayor for official approval and adoption in accordance with the aforementioned laws, administrative regulations, and planning guidance.

NOW, THEREFORE BE IT RESOLVED by the City Commission as follows:

- 1. The Barren County Emergency Operations Plan is officially approved and adopted effective the date of this Resolution.
- 2. The conveyance of the official approval and adoption of the Barren County Emergency Operations Plan through this Resolution shall remain in effect four years or until superseded by a subsequent Resolution promulgated in accordance with KRS 39B .030(3), KRS 39B .060(2), KRS 39C .050(3), applicable Kentucky Administrative Regulations, and planning guidance issued by the Kentucky Division of Emergency Management.
- 3. A copy of the officially approved and adopted Barren County Emergency Operations Plan, including this Resolution, shall be placed on file for public inspection during regular office hours in the Barren County Office of Emergency Management.

RESOLUTION NO. 05 - 23

A RESOLUTION ADOPTING THE NATIONAL INCIDENT MANAGEMENT SYSTEM (NIMS)

WHEREAS, In Homeland Security Directive (HSPD)-5, the President directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System (NIMS), which would provide a consistent nationwide approach for federal, state, local, and tribal governments to work together more effectively and efficiently to prevent, prepare for, respond to, and recover from domestic incidents, regardless of cause, size, or complexity; and

WHEREAS, the collective input and guidance from all federal, state, local and tribal homeland security partners has been, and will continue to be, vital to the development, effective implementation and utilization of a comprehensive NIMS; and

WHEREAS, it is necessary that all federal, state, local, and tribal emergency management agencies and personnel coordinate their efforts to effectively and efficiently provide the highest levels of incident management; and

WHEREAS, to facilitate the most efficient and effective incident management it is critical that federal, state, local, and tribal organizations utilize standard terminology, standardized organizational structures, uniform personnel qualification standards, uniform standards for planning, training, and exercising, comprehensive resource management, and designated incident facilities during emergencies or disasters; and

WHEREAS, the NIMS standardized procedures for managing personnel, communications, facilities and resources will improve the state's ability to utilize federal funding to enhance local and state agency readiness, maintain first responder safety, and streamline incident management processes; and

WHEREAS, the Incident Command System components of NIMS are already an integral part of various incident management activities throughout the state, including all public safety and emergency response organizations training programs and required by Kentucky law for all emergency responses; and

WHEREAS, the National Commission of Terrorist Attacks (9-11 Commission) recommended adoption of a standardized Incident Command System,
