Section 8 – Opt-Out Policy & Reasonable Alternatives
<i>As explained in our Notes for each consumable section, all consumables can be paid for as a daily saver package for £8.50 per day.</i> Alternatives to charges for meal and snacks – if you do not require meals and snacks you will need to provide the following meals - breakfast, one daily snack, Lunch and light dinner for your child. This will need to be delivered in the morning with your child in a secure cooler bag to keep the food fresh please follow Early years Foundation nutrition guidance – https://assets.publishing.service.gov.uk/media/6839b752210698b3364e86fc/Early_years_foundation_stage_nutrition_guidance.pdf <i>and also follow Natures Nursery Barn Pack lunch policy. Please also note our nursery has a strict no nut policy so no foods containing nuts will be allowed on site.</i> Alternatives to non-food consumables – parents will need to bring in their own baby wipes, sudacrem and sun cream. <i>Instead of the Famly App, parents will be provided with written and verbal feedback.</i> Alternatives to Extra Activities – children will be given other activities away from the extra curriculum paid activities if parents prefer not to pay for the extra activities. <i>Parents can opt out of all or specific services at any time by speaking to the manager or deputy manager and providing written notification of any changes to service provision.</i>
