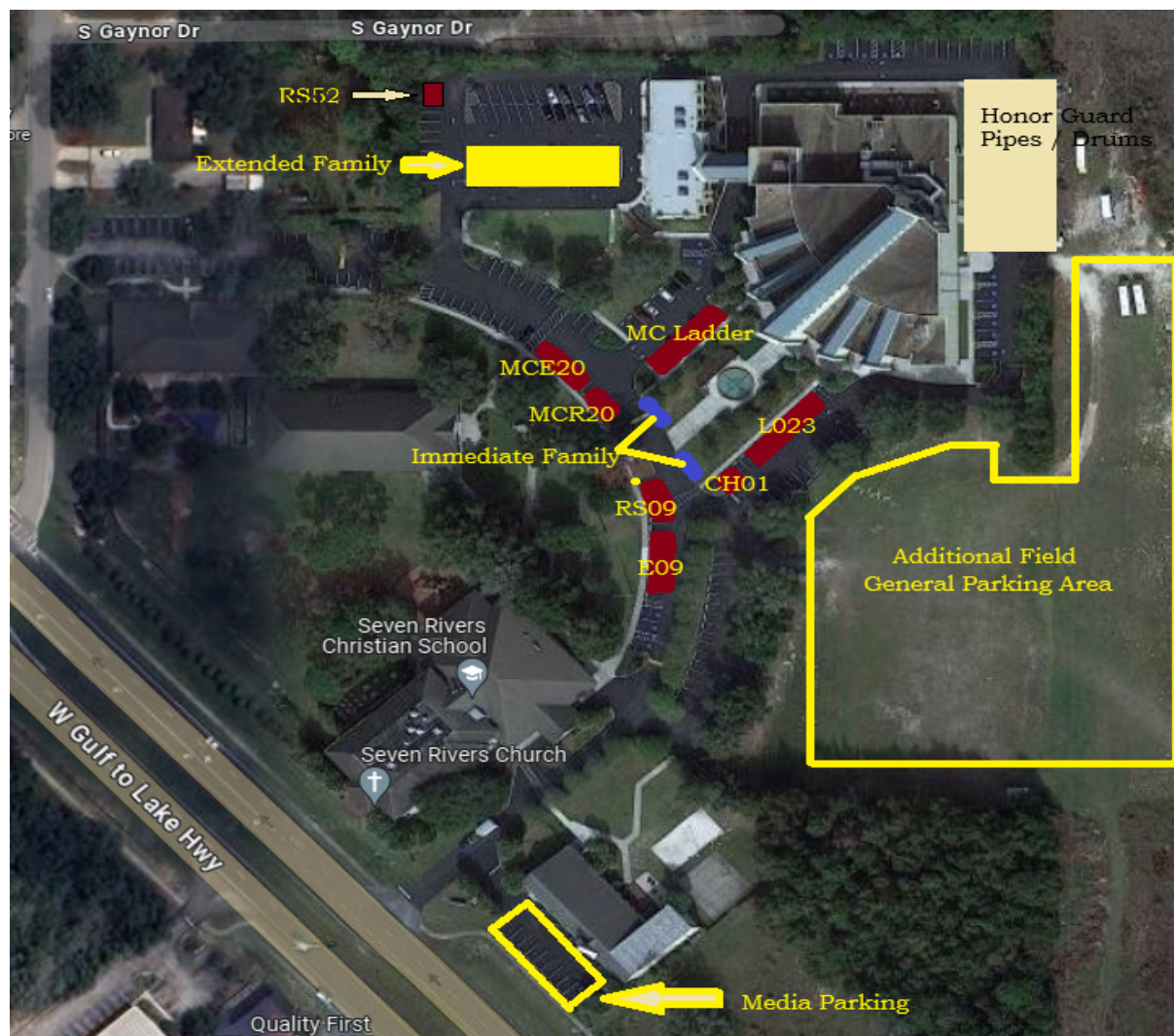

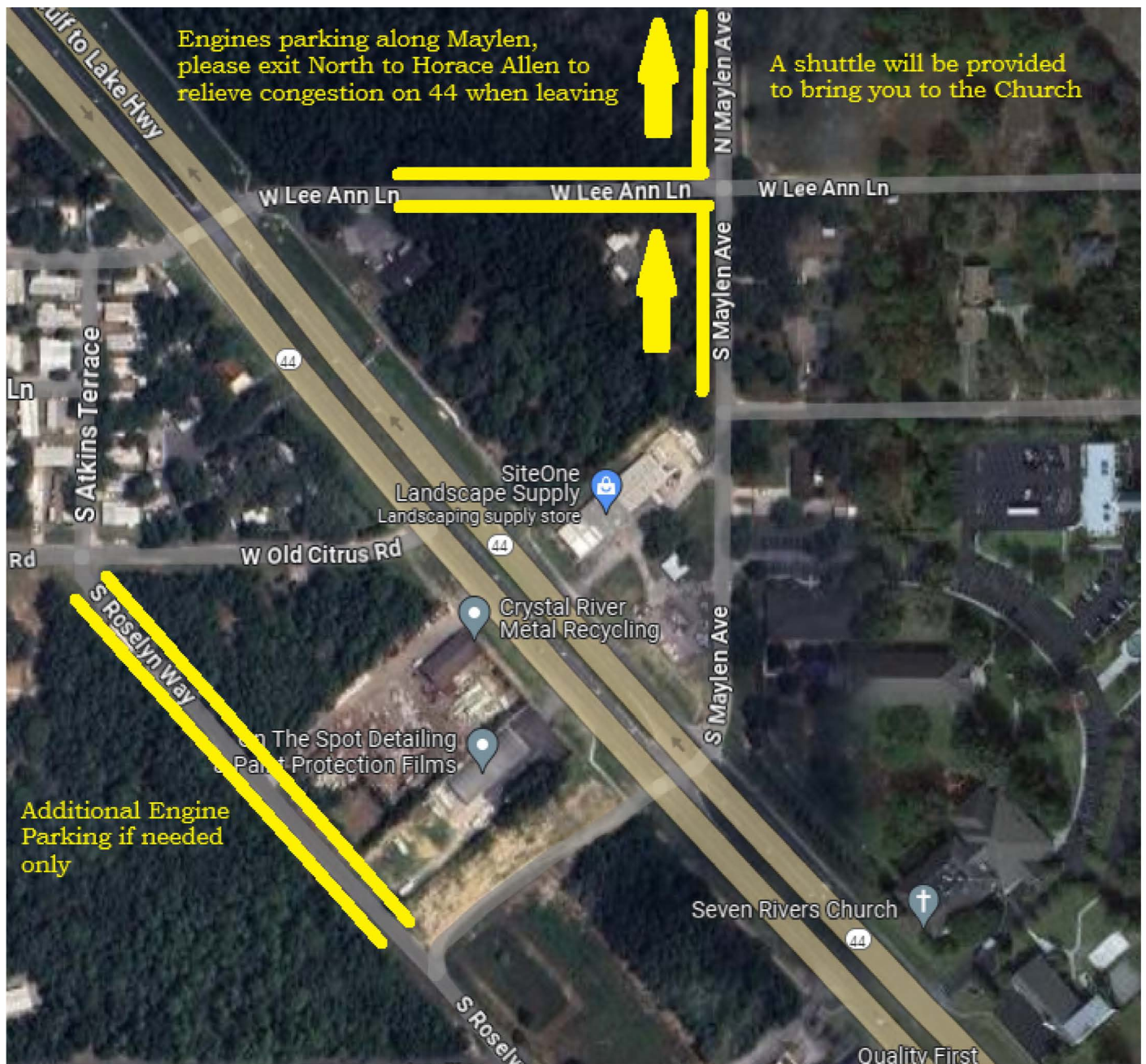

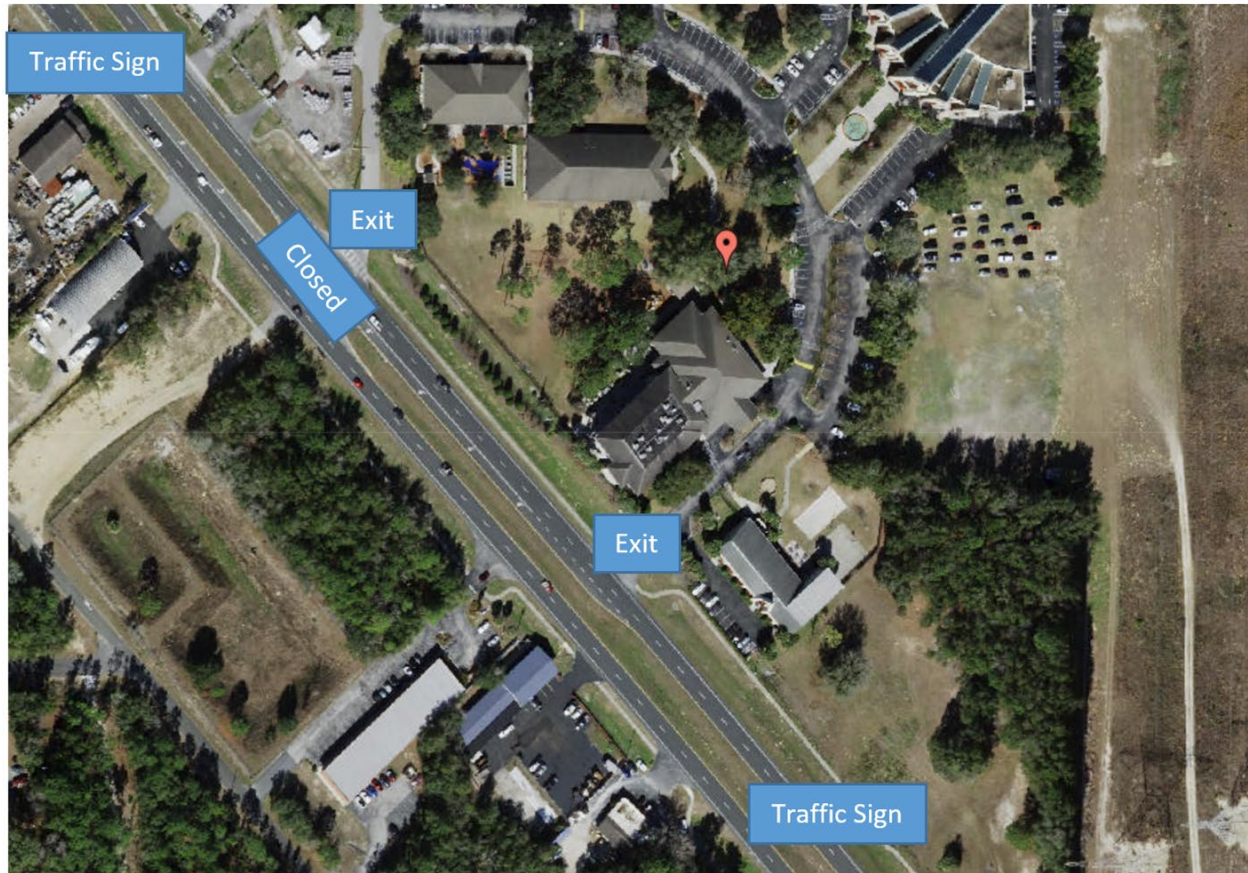
## Engine Parking



# CCSO Traffic Plan

This is a tentative plan and could change depending on crowd size or other conditions. Traffic will be allowed to exit the main entrance to 7 Rivers Church off Hwy 44 and only make a westbound turn. Maylen exit will be open and traffic can turn north or south on Maylen Ave. Maylen Ave and Hwy 44 intersection will be restricted to allow only westbound turns. All traffic leaving 7 Rivers Church will be directed west. The dirt road access east of the church needs to be closed. Vehicles needing to go East will be required to make the U turn at the next crossover after Maylen. Traffic cones will control westbound traffic and require all traffic to merge into the inside lane to allow the right of way for vehicles exiting 7 Rivers Church.

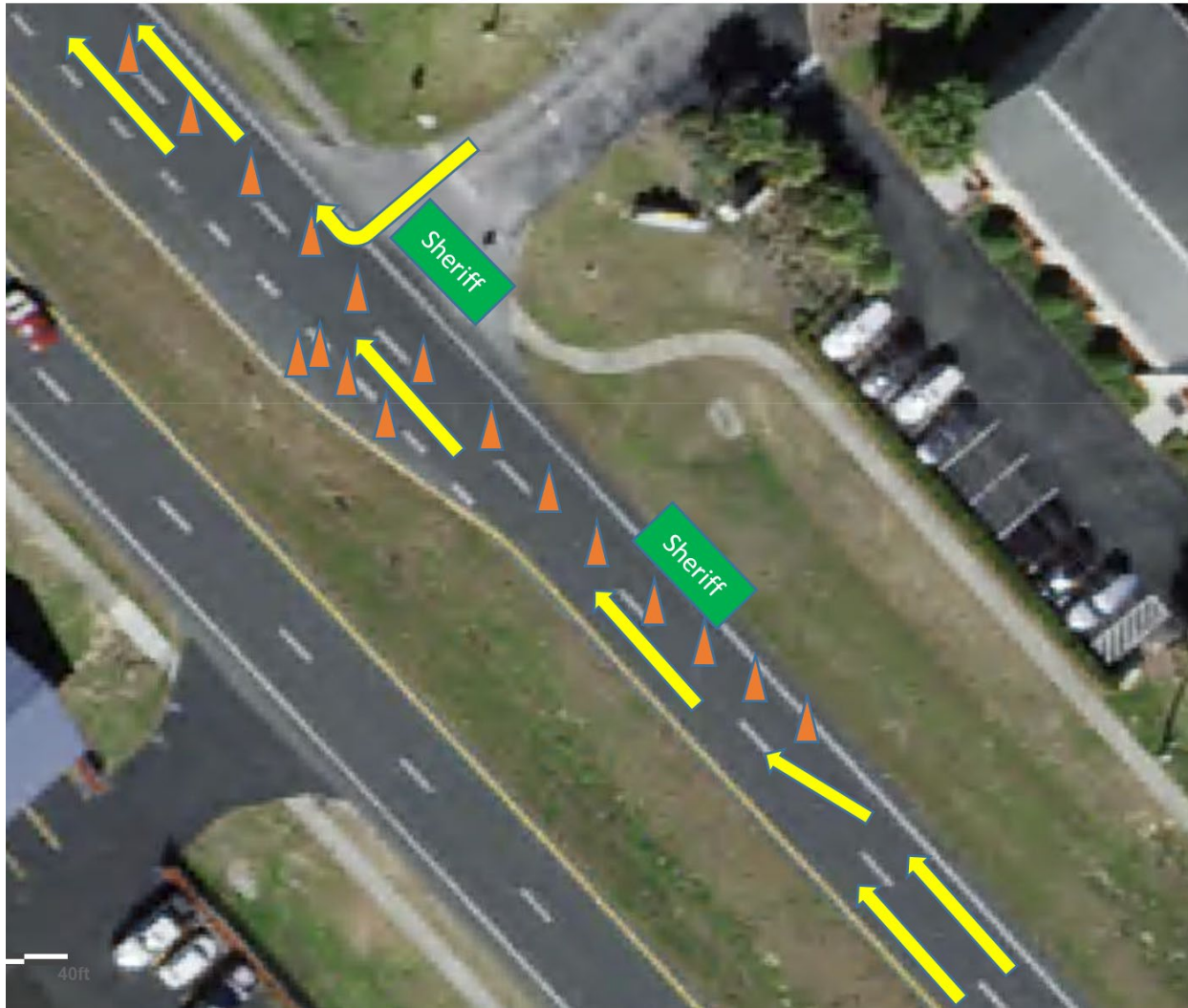

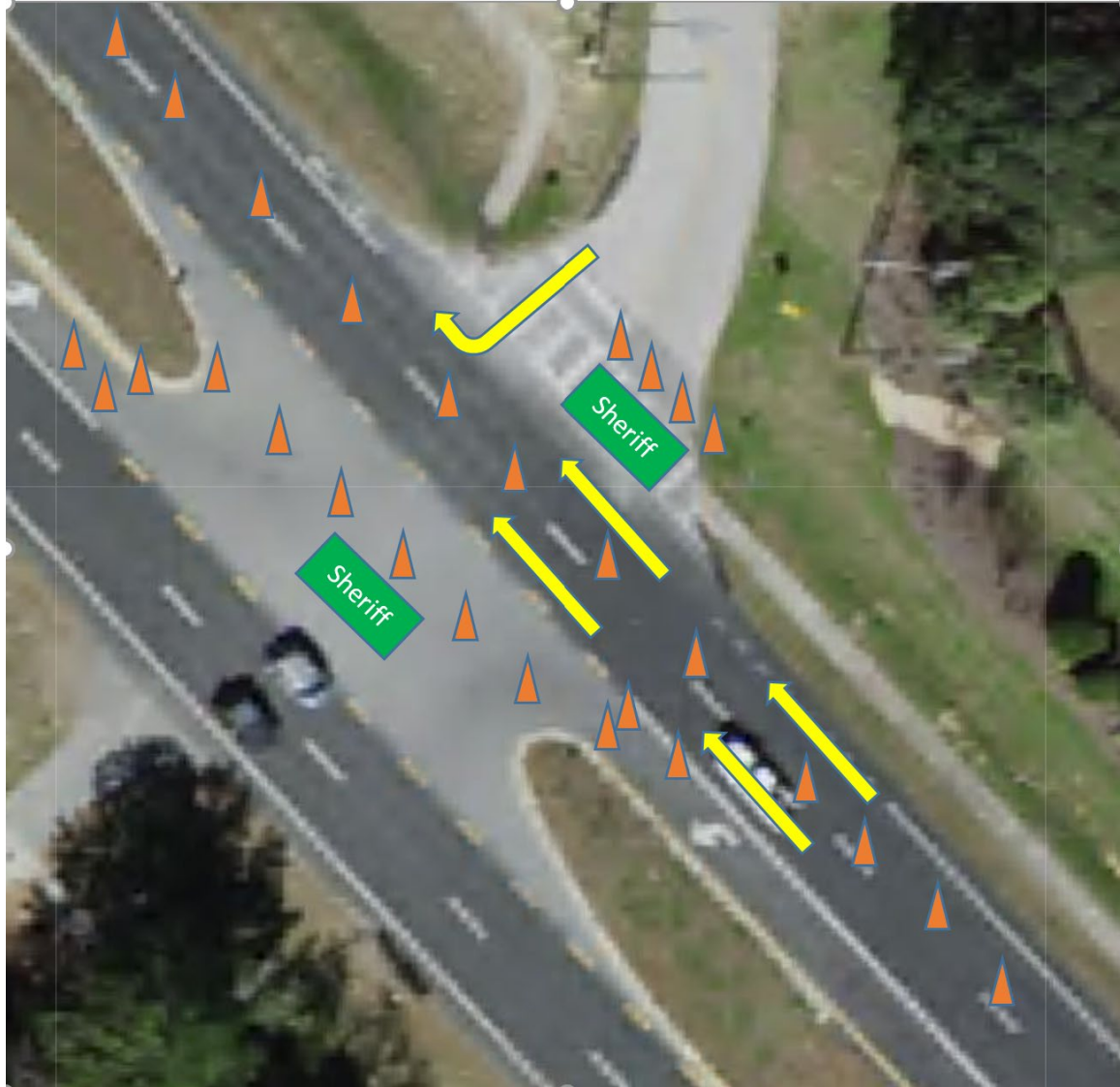
