Legal Description Units 1 through 26, Lakewood Estates Condominium No. C, Taney County, Missouri, according to the plat recorded in Book 14 Page 6, in the office of the Taney County Recorder ("Plat") and the Declaration of Condominium and Bylaws recorded in Book 242 at Page 994 in the office of the Taney County Recorder (the "Original Declaration").

Recitals:

- 1. Section 8.1 of the Original Declaration requires that liability for Common Expenses be allocated to each Unit according to its "percentage interest," as listed on Exhibit B (also identified as Schedule B) thereto, as either 3.616% or 3.948%.
- 2. Because the Common Expenses of the Association are not proportional to the area of Units, which is the apparent basis for the percentage interests of each Unit listed on Exhibit B, also the Owners of all the Units in Lakewood Estates Condominium

No. C, referred to here as "Oak Court" wish to change the percentage interest of each Unit in Oak Court to be equal, by replacing Exhibit B.

- 3. Section 14.2 of the Declaration provides that percentage interests listed on Exhibit B may be changed only with "the written assent of at least 75% of all the condominium owners and all the holders of obligations secured by deeds of trust against the condominium property."
- 4. Various other sections of the Original Declaration refer to each Unit's undivided interest or percentage interest, and the Owners intend that the equal percentage interest listed on the Amended Exhibit B, attached hereto, be applicable to all such instances.

Now, therefore, the Association, through the undersigned assent of the 100% of the Owners with the written assent of all mortgagees, declares as follows:

Section 1. Amendment of Exhibit B

Exhibit B (also called Schedule B) to the Original Declaration is hereby deleted and replaced with an Amended Schedule B, which is attached hereto.

Section 2. Intent of Owners

The Owners intend that the equal percentage for each Unit, or 3.846%, be applicable to all instances mentioned in the Declaration or Missouri statutes where the undivided interest or percentage interest allocated to each Unit is applicable.

This amendment has been approved by the undersigned members of the Association, who are owners of 75% of the 26 units in the Condominium.

Amended Schedule B

The percentage interest of each Unit in Oak Court is 1/26th, or 3.841% for all purposes.
