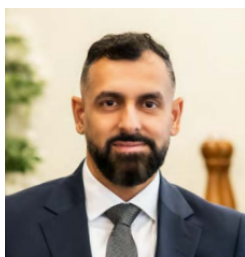

**SUBJECT:** Notice Regarding Proposed Bylaw – Delegation of Duties to Non-Regulated Personnel (Section II.6 – Mandatory Training Requirement)

The Manitoba Dental Association (MDA) Board of Directors has approved the Bylaw for the Delegation of Duties to Non-Regulated Personnel, which is currently under membership ratification pursuant to Section 43(2) of The Dental Association Act.

This memorandum pertains specifically to Section II.6 of the proposed bylaw, which states:

“Any individual performing infection prevention and control procedures in a health setting including operatory set up, instrument reprocessing and sharps disposal must have completed explicit training as approved by the Registrar.”

If the bylaw comes into effect on August 1, 2025, the implementation of the training requirement under Section II.6 will be deferred for a period of six (6) months. This deferral is intended to provide affected individuals with sufficient time to obtain the necessary

training. As such, the mandatory training requirement would come into force on February 1, 2026.

Registered Dental Assistants are exempt from this requirement, as their existing education already meets the necessary competencies outlined in the bylaw.

The MDA will provide additional notice once the bylaw comes into effect, including details on how and where the required training will be accessible.
