Additional Membership Rules unanimously adopted by the P&S Membership 6/21/2025:

- A. Only Members in good-standing are eligible to earn points to year-end awards.
- B. Only Members in good-standing will be eligible for seasonal stall rentals.
- C. Members in good-standing have the privilege of utilizing the Grounds for the duration of the show season. Opening and Closing of the Grounds is weather dependent and will be determined and announced by the Grounds Chair, however, are typically between May 15th and October 31st. *Please note that Youth riders must wear a secured ASTM-SEI helmet WHENEVER mounted on the Grounds.*
- D. Membership Renewals at the published rates are due yearly by May 31st, after which there will be an additional \$10 late fee applied.
- E. Points will only accumulate toward Year Ends from the date which Membership Form and Payment is received.
- F. Membership will run from October 1st to October 31st of the following year.
- G. Annual membership meeting will be held in the month of October at a location determined by the Board of Directors
- H. Membership in good-standing is defined as any member who has paid their yearly dues and whose Membership Form is signed and is on file with the current Membership Chair and or Secretary
