Notes/Narratives

On 10/22/15 Operations Division Midtown Community Response Team officers were working in the area of 689 S. Lakeshore Rd in unmarked vehicles surveilling the parking lot for suspicious activity and possible vehicle break ins. While parked in the parking lot Ofc Frank (48350) and Ofc Roberts (51909) observed a blue 4 door sedan in the parking lot occupied by 2 individuals. Ofc Frank advised he could see the seat was reclined and a male was facing down on the seat. He stated he could then see the male [REDACTED] He stated he then saw the male stop then a female appeared from below him then she moved to the other seat in the vehicle. Ofc Frank also identified there was what appeared to be a family with 2 small children in the parking lot and in the vicinity of the vehicle. See Ofc Frank and Ofc Roberts supplements for full details.

Ofc Magnussen made initial contact with the vehicle where he spoke with Jessica [REDACTED] and Randy [REDACTED] Both parties stated they came to the park to hang out and have been here for about 20 minutes and were watching the sunset. Both parties stated they were "just kissing." Both parties were cited and released for lewd acts. SB1070 check was completed on both which returned negative.

Supplement Notes

On 10/22/15 Operations Division Midtown Community Response Team officers were working in Reid Park in unmarked City of Tucson vehicles, watching the parking lot for suspicious activity and possible thefts from vehicles.

I was in an unmarked City of Tucson vehicle in the parking lot northwest of the entrance to the Reid Park Zoo. A dark blue four door sedan parked in the lot approximately thirty feet northeast of my location. The vehicle was at the end of a parking row so there was no other vehicle south of it. The sun was setting, but there was still a good amount of light out.

The vehicle was facing west and my vehicle was facing east. I had an unobstructed view of the vehicle and the driver's side window of the vehicle. I observed a Hispanic male in the front seat of the vehicle wearing a white t-shirt, facing down, with his back arched, and his waist was [REDACTED] (appeared to be sexual intercourse). I advised over the radio to the other officers what was happening. Ofc Magnussen #52790 said he would respond and make contact. After approximately thirty to forty five seconds, the motion stopped and the male turned to his side (his back was to me). A female emerged from underneath him. It was at this point that Ofc Magnussen approached the vehicle in a tactical vest and identified himself as a police officer; Ofc Morales #53362 also responded in a marked patrol vehicle. I remained in my vehicle during the interviews; I did not speak with either subjects.

Ofc Morales conducted an interview with the male and he denied what I saw. I told Ofc Morales that there were families and children standing outside a vehicle directly west of the suspect vehicle while the incident was occurring. There was no window shade in the suspects vehicle. Based on the facts and circumstances, a reasonable person would believe that the male and female were having sex in the vehicle. Ofc Morales advised me later that both subjects were arrested for Lewd Acts.

Supplement Notes

On October 22, 2015 I was assigned to the Operations Division Midtown Community Response Team (ODM CRT). ODM CRT officers and I were in the area of 689 S Lakeshore. I was parked in a parking lot on Lakeshore, just west of the Aquatic Center. There were several other cars parked in the parking lot, and several people walking around to include children. There was also an event taking place at the Reid Park Bandshell, west of, and a few people appeared to be parking in the parking lot and walking over to the event.

I observed a dark blue four door sedan drive into the parking lot, and was occupied by a male and female. After parking near other vehicle no one exited the vehicle. The vehicle parked facing the park (westbound) and did not appear to have a window shade up. Approximately ten minutes later (approximately 1730 hours) I looked over at the vehicle, which had parked about 6-7 parking spaces south of me with no vehicles between us. I had my windows rolled down partially, and they did as well. I observed the male laying face down on the passenger seat, which was reclined, and could not see the female. It appeared the male was kissing the female. A few minutes later the male [REDACTED] and then layed back down on the female. I could observe the males [REDACTED] multiple times. I advised ODM CRT officers of the activity I was observing, and Ofc Frank, 48350, advised he was observing similar activity. Approximately less than a minute later the male lifted his hips up again, reached for his groin, and rolled over into the driver's seat. As the male was rolling over into the driver's seat Ofc Magnussen, 52790, was approaching the vehicle on foot to make contact.

I had no further involvement. NFI

On 10/23/15 I was assigned to Operations Division Midtown Community Response Team (ODM CRT). On that day ODM CRT was working in the area of Reid Park on Lakeshore Rd in unmarked vehicles, surveillance the parking lot for suspicious activity and possible vehicle break ins. While parked in the parking lot Ofc Frank (48350) and Ofc Roberts (51909) observed a blue 4 door sedan in the parking lot occupied by 2 individuals. They advised me that they believed that the two persons were having sex in the front seat of the vehicle. They also advised that there were people walking in the parking lot around the area of the car with kids.

I put on my marked tactical police vest and made contact with the two persons, a male and female later identified to me as Randy [REDACTED] and Jessica [REDACTED] with Arizona picture identification cards. As I was walking up to the vehicle I could see the man rolling over towards the drivers seat and a female sitting up in the front passengers seat. The front passengers window was rolled down and there was no window screen in the windshield. I verbally identified myself as a police officer and began to speak with the two persons, they appeared to be nervous. While speaking to them at the front drivers side door they both appeared to be fully clothed, however they were both fixing their shirts and pulling the bottoms of their shirts down on their pant waist lines.

I asked them if they knew why I was contacting them and they advised they did not. I told them police had received reports that people had seen them having sex in their car. When I told them this, they then told me that they had been making out. They both advised that they had been dating for about a year and that Randy was taking Jessica home when they decided to come to the park to talk. Randy admitted to me that he had been on top of Jessica moving his hips, however he denied having been having sex with her. He said he was just [REDACTED]. As I was speaking with them I could see several people walking in the parking lot about 15 ft west of the front of the car as it was parked facing west. With the people there was also a person who appeared to be a juvenile.

At about this time Officer Morales responded to assist me with the stop in a marked police vehicle. We separated the two and I spoke with Jessica. I read her the Miranda warning at 1751 hours and she said yes to both questions. Jessica denied having sex in the car, however she admitted to making out and kissing Randy who she said was on top of her. She said he had been [REDACTED] however he had never exposed himself. She also stated that she could see how people might think they were having sex, but they were not.

Jessica and Randy were cited and released for lewd acts (city code violation). I completed an SB1070 check at 1804 hours with TWX operator # 100415. Both Randy and Jessica were provided with citations after they signed a copy for police.
