On 07/20/2024 I responded to 5620 W Cortaro farms in reference to a possible aggravated assault victim who was currently at the hospital.

On my arrival, I spoke with Elizabeth Duenes, the registered nurse for Krishna. Elizabeth stated, "She was assaulted just after midnight this morning at Speedway and Silver bell and she knows who did it". That is all Elizabeth told me.

I then sat down and spoke with Krishna Mollhoff. Due to the call text of her telling hospital staff she would not like to speak with officers. I had told her I'm not going to force you to talk to me but I would love to talk so we can help her out and do our best for her. She stated she would not like to talk and make a report. Krishna then stated that her wife works for TPD and stated she was a commander. I asked what her last name was and she said Lt. Cunningham. She then stated she is in Boston on a commanders meeting with several other commanders with the Tucson Police Department. Krishna also stated that her wife is the commander for the wellness division. I asked her for clarification on where exactly the incident happened and she stated she lied to the doctors about Speedway and Silver bell location because she was getting frustrated with all the questions they were asking. Krishna then stated the incident occurred on "El Moraga Dr" where she "fell on her face". She would not talk to me about anything else incident related.

Krishna had approximately 50 stiches to her face with three significant slash wounds to her face. Both of here eyes were bruised and swollen along with her lip. Her right hand had significant swelling and was black and blue as well. Both of her arms had bruising consistent with being in some sort of physical altercation.

Sgt. Santamaria was advised and responded to the scene.

Deputy Hanover responded as well #9601 and they will be using case 240720147.

## Narrative

### Narrative

On 7/20/2024, I was assigned to our Operations Division West and was operating as a solo uniformed officer in a patrol capacity when I responded to the Carondelet Mariana Hospital located at 5620 W Cortaro Farms Rd at the request of Sergeant Santa Maria.

Officer Swanberg was already on scene at the listed reference an assault victim call that possibly occurred in the area of W Speedway and N Silverbell in the City of Tucson jurisdiction. Sergeant Santa Maria advised the victim was not very forthcoming but had pretty good injuries and requested I respond and see if the victim would be willingly to speak with a female officer instead.

Upon arrival, I spoke with Officer Swanberg who advised the victim told him the incident actually occurred in Pima County jurisdiction and told hospital staff it was in the city because that was what she was able to come up with at the time. Sergeant Santa Maria then requested I hold off speaking with the victim until Pima County Sheriff's responded out and took over the investigation. I then stood by outside of the hospital room until Pima County Sheriffs responded and attempted to speak with the victim. The deputy with the Pima. County Sheriffs advised the victim did not want to provide a statement.

I then cleared from the scene. I never entered the hospital room the victim was in and never spoke with the victim.

## **Narrative**

### **Narrative**

On 7/20/2024 I was contacted by Officer Swanberg who advised me of an aggravated assault call. Officer Swanberg advised me the victim suffered several lacerations and needed a significant amount of stitches. Officer Swanberg advised me the victim told him she was married to a member of the Tucson Police Department and when asked who the member was the victim informed Officer Swanberg she is married to Lieutenant Cunningham. Officer Swanberg advised me the victim, identified to me as Krishna Mollhoff, stated Lieutenant Cunningham was out of town for work. Officer Swanberg stated the victim did not want to speak with him further. Officer Swanberg did state the victim admitted to him she lied about the incident occurring at W. Speedway and N Silver bell and informed Officer Swanberg the incident occurred on El Moraga Dr. Officer Swanberg confirmed El Moraga was in the county jurisdiction. I instructed Officer Swanberg to remain on scene.

I contacted Lieutenant Mechtel who was the on call Lieutenant at the time. I advised Lieutenant Mechtel of the information I was provided. I responded to Officer Swanberg's location and while on my way I contacted the Pima County Sheriff's Department's communications. I requested a call for service entered and requested an on duty Supervisor contact me.

I spoke with PCSO Sgt. B Cross and provided him with the information I received. PCSO Sgt. Cross advised me he would have a deputy respond. I also contacted Det. Dowling with the Tucson Police Department Aggravated assault unit and advised him of the information I was provided.

I arrived at the Marana Hospital with Officer Swanberg and shortly after Deputy Hanover #9601 arrived. Officer Swanberg briefed Deputy Hanover.

Deputy Hanover took over the investigation and after speaking with the victim he told me the victim did not want to report the incident stating it was a family matter. Deputy Hanover confirmed the incident occurred in county Jurisdiction. I advised Lieutenant Mechtel.

Later in the shift I was contacted by PCSO Sgt. Cross who advised me they would be conducting follow up at the victim's residence. A short time later I was advised deputies were allowed into the residence and a scene was located inside. I was also advised PCSO Detectives may be responding. I provided Deputy Cross with Lieutenant Cunningham's name and work phone number.

I then spoke with PCSO Deputy Duarte #7653 who called Tucson Police Communications requesting to speak with a supervisor. I provided PCSO Det. Duarte a summary of the incident. PCSO Det. Duarte requested information on Lieutenant Cunningham's location and when she is due to return. I advised him I would contact my chain of command. Det Duarte advised me he had information stating Lieutenant Cunningham may returned however it was not confirmed.

I advised Lieutenant Mechtel of the updated information and I was instructed to provide the Detective with Captain Pickrom's contact information. I called Det Duarte and provided him with Captain Pickrom's contact information. I completed this report along with my involvement in this case.
