On 07/05/2025 I was operating at a patrol capacity in operations division south.

At 1745 hours I was dispatched to the Circle K located at 1025 E Ajo Way in reference to an exposure call. Call text read that there was a male exposing his genitals to customers.

Upon my arrival the suspect had already left the area. I spoke with the complainant who identified herself as [REDACTED] who is an employee of Circle K. [REDACTED] stated that she had observed a male enter the business around 1620 hours and loitered around the store for about an hour. During the time that the male was inside the business his pants repeatedly fell to his knees, exposing his genitals. [REDACTED] stated that she had observed the entirety of the male's genitals on three separate occasions while the male was on property. Eventually the male left the store. [REDACTED] also mentioned that the male had shoplifted a couple items however she had already completed a report for the items taken.

I spoke with the other clerk who was present at the time who identified herself as [REDACTED]. [REDACTED] stated that the only time she had seen the male was from a trash run earlier in the day where she had observed the male outside the business. [REDACTED] stated that she had only seen the male's exposed buttocks and specifically did not see his rectum.

I reviewed the camera footage showing the incident. At no point can you see the male's exposed genitals from the angle of the cameras, but it is visible that the male's pants were worn low.

The suspect was described to be a white male, 40s-50s, with shaved hair, and facial hair.

I downloaded a copy of the video feed for evidence.

While on scene, a passerby mentioned that someone had attempted to place their genitals into a beehive down the street at 3601 S Park Ave. The passerby requested to remain anonymous. The mentioned incident was in reference to Tucson PD event E251861006 where police were requested to block traffic to prevent pedestrians from getting stung by bees. Dispatch informed me that the subject from that incident had been taken to Banner South by Paramedic 10.

I conducted follow up at banner south and located the male suspect matching the description from the video feed. I identified the male as Michael Crawford from his tattoo's and from previous contacts to include 'Crawford' tattooed on his arm. Hospital staff confirmed that the male was Michael Crawford.

Michael was in shock from the bee stings and was not able to speak with police at this time.

I posted a stop and interview for Michael reference broadcast #353214

I provided [REDACTED] with a victim's rights form.

TWX #201624 provided me with a triple I report which showed no prior instance of indecent exposure for Michael.

Sergeant Solarino #100962 was advised.

This concludes my involvement with this case at this time. NFI.
