On 12/12/25, I responded to Broadway and 6th Ave reference a request for assistance with an impaired driver investigation. Upon arrival, I spoke with Officer Flynn and he provided the following information.

Officer Flynn was driving east on Broadway and observed a Ford Fusion (AZ/BYJ1714) fail to stop for a red light at Scott Ave. Officer Flynn said the vehicle did not make any attempts to slow or stop for the red light as he didn't see the brake lights activate. After the vehicle stopped, he observed the driver immediately start exiting his vehicle. Officer Flynn said he contacted the driver and it seemed the driver had forgotten he had started exiting. Officer Flynn told me he was concerned because of how quick the driver forgot that detail and that he did not know he ran a red light. He provided me with the an Arizona driver license that identified him as Emiliano Reyes.

I made contact with Reyes who was seated on the curb. I asked Reyes if he had any drugs or alcohol tonight and he said no. I told Reyes to stand and I could see he had bloodshot eyes, his pupils appeared dilated for the lighting conditions and I could smell the odor of burned marijuana coming from his breath.

I directed Officer Lushbaugh to move the Ford out of the roadway since it was blocking the street car tracks.

I moved Reyes away from the roadway and I administered the HGN test. I did not observe any clues. During the test I observed Reyes to have an upper body sway. He also required repeated reminders to keep his eyes on the stimulus (blue pen light). I check him for eyelid tremors and they were present. I checked him for lack of convergence and it was present (right eye converged, left eye looped away).

I provided the instructions/demonstrations for the walk and turn test. Reyes told me he's "not good at doing a straight line" but that he understood the instructions. As I was about to have him start, Reyes asked if he is supposed to walk to his car. I told Reyes that he is to take 9 heel-to-toe step, turn how I showed him and take 9 heel-to-toe steps going back. I asked him if he forgot the instructions and reminded him that he said he understood them. Reyes asked me to repeat everything and I repeated all of the instructions/demonstrations. Reyes again said he understood. I had him perform the test and I observed 2/8 clues. I provided the instructions/demonstration for the one leg stand test and Reyes said he understood the test. Shortly after starting the test, he asked "can I do it with this foot" and I reminded him he picks which foot to stand on. He switched feet and continued the test. I observed 4/4 clues. He required repeat reminders to count out loud and look down at his foot.

Reyes submitted to a PBT and he tested negative for alcohol.

I read the Miranda Warnings to Reyes ("Yes", "Yeah, yes") at around 0108 hrs. and asked him the questions on the DUI worksheet. Reyes again denied using any drugs. I asked Reyes about the red light and what happened. Reyes said he was "in a rush to get somewhere". I asked him where he was going and he said to a friend's house. I asked him where the friend's house is and he said "It's by St. Mary's". I asked him if he means St. Mary's Hospital and he said his friend's house is near there. I told him he was heading the wrong direction and Reyes said he had to get cigarettes. I asked him where he was heading to and he said a smoke shop. I asked which smoke shop and he seemed confused about where he was going. Reyes said he "heard" there was a smoke shop "somewhere near here". I asked him if he was using his phone navigation and he said yes. I asked him if he saw the red light and he said, "I didn't see the red light on my phone". I told him I was talking about the traffic light and he said he "didn't see it". I asked Reyes where he was coming from and he said "Pima downtown campus". I asked him for the address of the smoke shop and he said he didn't know and "I was gonna put it in". I asked him again if he was using any kind of navigation and he said he was "looking at it from the map". I asked him again for the name of the smoke shop and he said Mezo Smoke Shop. I performed an internet search and found four smoke shops with that name at 1726 E Speedway, 20 W Ft. Lowell. 2402 N Campbell and 4949 S 12th Ave. I told Reyes that he was not close to the smoke shop. He asked if there were any smoke shops "down here" and I reminded him that he was the one that said Mezo smoke shop. Reyes said he was "gonna head to a smoke shop" and doesn't remember the "exact name". He also said "I know that there is one near here, though". I asked Reyes if he used marijuana today and he said no. I asked him if he was sure and he said "I'm sure". I asked "how sure" and Reyes said "Well, I smoked". I told him of the odors I detected and then asked when he smoked. Reyes said "A few hours ago". Reyes said he smoked "a joint". I placed Reyes under arrest for DUI.

I read the Admin per Se/Implied Consent Admonitions to Reyes and he refused testing. I read the warnings for refusal and Reyes started backing away. I told him not to walk away and to return to me but refused. I reached out to take control of his arm and he started pulling so I placed him in handcuffs and continued with the admonitions. I asked him if he would consent to testing but he would not respond and he had started crying. He was placed in the backseat of a police vehicle. I directed Officer Flynn to transport Reyes to the westside police station.

I applied for an electronic search warrant with the Maricopa County Superior Court. The warrant [REDACTED] was granted.

I met with Reyes at the police station and asked him if he would consent to a blood draw and he said yes. I served the search warrant on him. I collected two gray top tubes of blood from his right arm. He was seated and there were no complications with the draw.

Officer Schrage completed a drug influence evaluation on Reyes.

I submitted the blood kit into evidence.

On 121225 while working as an officer of the impaired driver enforcement unit, I responded to 1310 W Miracle Mile to assist officers with a DRE investigation.

Upon arrival I was advised that Emiliano Reyes had conducted SFST's and showed signs of impairment. A preliminary breath test had been conducted, and the device read no presence of alcohol. Emiliano had been placed under arrest for DUI impaired to the slightest degree.

I made contact with Emiliano as he sat in the holding area of the west side substation. I observed him to have red watery eyes, delayed responses, slowed movements, quiet speech, droopy face and eyes, and the distinct odor of marijuana coming from his person.

I then conducted a DRE investigation with Emiliano. See DRE report for further information.

It is my opinion as a DRE that Emiliano Reyes was impaired by Cannabis and was not safe to operate a motor vehicle.

## Narrative

### Narrative

BWC activated with muted sections for conversations with officers.

On 12-12-2025 at around 0120 hours I was driving in a marked patrol car eastbound on Broadway when I observed a red 4 door car drive through a solid red light at the intersection of Scott and Broadway. Post the driver failing to stop for the red light and continue on eastbound I activated my red and blue emergency lights and conducted a traffic stop at the intersection of 6th Ave. and Broadway.

Upon initiating the traffic stop, I observed the vehicle slowly pull over the right side of the road. As the vehicle came to a complete stop, I saw the driver's hands go through the open window and open the driver side door and begin to step out of the vehicle. The door got approximately halfway before closing and then rolling the window up.

Based on my training and experience, drivers open the doors pose a risk of flight or fight to officers. Due to this behavior of the driver, I called for a backup officer to come on scene. I made contact with the driver on the driver side after watching him from the back end of my car for approximately 1 minute and noticing no more unusual behavior.

As I approached the driver, I asked him why he opened his door. To which he stated not remembering opening the door. I asked him if he knew why I pulled him over, to which he stated he did not. I observed the drivers' pupils were very large and due to how he was answering my questions and not remembering action he just made less than approximately 5 minutes ago I asked him to step out. I then escorted him over to the side of the road and called for a DUI officer to come conduct a rule out.

I then explained to the male, who was now identified as Emiliano Reyes, the reason for the traffic stop and that I would need his driver license to which he complied. It was at this time that Ofc Santa Maria arrived on scene and took over the DUI investigation after being briefed by myself on the reason for the traffic stop and what I observed.

I then stood by with Ofc Santa Maria for the field sobriety test. I was advised by Ofc Santa Maria that Emiliano would need to be transported to the westside substation for further testing. I then transported him there and stood by during this testing.

I stayed on scene until I was cleared by Ofc Santa Maria.

This concludes my involvement in this case at this time.

## Narrative

On 12/12/25, I responded to the area of E Broadway and S 6th Ave after Ofc. Flynn had requested a second unit to his traffic stop. Upon arrival I observed Ofc. Flynn speaking to a male behind a red sedan. Officer Flynn was explaining to the male his reasoning for the stop. It was my understanding the male driver had failed to stop for a red light.

I stood by while we waited for a Traffic unit to respond; Ofc. Flynn had detected signs and symptoms of impairment. The male was later identified as Emiliano Reyes. Officer Santamaria, with the DUI unit, responded to our location and proceeded with a DUI investigation. Several minutes later, Ofc. Santamaria advised me that Reyes had failed all field sobriety tests and was now under arrest. Furthermore, he advised that he would be requesting a search warrant for Reyes' blood. Reyes was subsequently transported to the ODW substation for the blood draw and to conduct further test to reveal the possibility of narcotics in his system.

I stayed behind with Reyes' vehicle and contacted [REDACTED], at his request to pick up his vehicle. A few minutes later, [REDACTED] arrived at our location, and I advised him of the incident. I provided him with the vehicle keys and gave him directions to the ODW substation.

This concluded my involvement in this case.
