This incident was recorded with my body worn camera. I muted my BWC while speaking to other officers.

I responded to the listed incident location to assist Ofc Voss 43601 who requested emergency assistance. Upon arrival Ofc Voss was holding a handcuffed male (identified as Dylan Birdsong) down on the floor just outside the western business doors. I relieved Ofc Voss, placed Dylan in the recovery position and a few minutes later sat him up against the business wall.

At 0935hrs I advised Dylan of his Miranda Rights and he said, "Yeah" and "Yeah I will". Dylan was rambling about being punched in the face, being kicked on the ribs, and the officer putting his thumb on Dylan's throat. I asked Dylan if he had any injuries and he said he did not know. Dylan indicated he was punched on the left side of his face, kicked on the left side of his torso and the thumb put on the left side of his neck. The left side of Dylan's face/eye was slightly red and there was a small bump. The left side of Dylan's torso was red. There were no visible injuries to Dylan's throat but there was a red mark/loose skin behind his left ear as if a pressure point was applied. Ofc Davis 47230 took photos of Dylan's injuries.

Dylan stated this morning between 0230-0330hrs he went to the listed incident location and sat near the pallet of water in front of the business. Dylan believed he fell asleep and at approximately 0430hrs the officer (Ofc Voss) "ran up on me" and told him that I "better get the fuck out of here" and that I was on the "wrong side of Craycroft". Ofc Voss told Dylan that he was not supposed to be there so Dylan got his belongings and went across the street to the bus stop then into the wash to sleep. I asked Dylan if Ofc Voss was in full uniform and a marked patrol vehicle and he said he was. Dylan indicated shortly before the incident, he went back to the incident location to use the bathroom. Dylan indicated he had used the stall and as he was walking out of the stall, Ofc Voss walked into the bathroom. Ofc Voss told Dylan that he had seen him earlier and told him that he was not allowed to be sleeping there. Dylan indicated he tried to explain himself but Ofc Voss told Dylan that he was going to "beat my ass". Ofc Voss punched Dylan on the face three or four times, kicked him on the ribs once or twice then put him on the bathroom floor. Ofc Voss drug Dylan out of the bathroom and held his head down once outside and just before other officers arrived.

I later completed the Injured Person Report.

Sgt Pelton 39293 responded and spoke to Dylan. I then advised Sgt Pelton of Dylan's statements as Ofc Velazquez 43129 stood-by with Dylan. I took photos of Ofc Voss (dirt on right pant leg/knee area) and his injury (skin tear on his right thumb). Ofc Voss had a scrape on his left index finger that he indicated was a previous injury.

I then contacted manager Amanda Valentine and asked if we could review the surveillance video which she said we could. While watching the video, Amanda said she arrived at work and saw the male (Dylan) sleeping in front of the business at the pallet of water. Amanda walked up to Dylan, tapped his foot with her foot to wake him up and asked him to leave. A short time later Ofc Voss came into the business and told her that Dylan was sleeping in front of the business so he asked him to leave which he did.

In reviewing the surveillance video, it showed Dylan arrive at 0153hrs with his bags/personal items. Dylan purchased some items and walked out of the business at 0204hrs. Dylan took his bags/personal items and placed them near the pallet of water where he walked around the laid down in front of the pallet at 0240hrs. Dylan laid down and walked around until 0409hrs where he went into the business then came out at 0412hrs and laid down in front of the water pallet. At 0508hrs Amber contacts Dylan where she has brief interaction with him and she goes into the business. At 0511hrs Ofc Voss (in full uniform) is seen walking up to Dylan from his POV, they have a brief interaction and Ofc Voss walks away into the business as Dylan walks away northbound. At 0515hrs Ofc Voss leaves the business, gets into his POV and leaves. At 0648hrs a person with the similar description as Dylan walks back onto the property from the north, puts their belongings down near the pallet of water and stays in the area. At 0720hrs a van parks in front of the pallet of water and when it moves several minutes later, that person/property is no longer in front of the pallet of water. We reviewed the surveillance video but could not locate when Dylan went back into the bathroom. At 0930hrs Ofc Voss is seen walking into the bathroom. At 0930hrs Ofc Voss is seen walking Dylan out of the bathroom in handcuffs.

After watching the surveillance video, at no time did I see Ofc Voss "run up on" Dylan and in the early morning, Ofc Voss was in full uniform but he was in his POV. After the incident in the bathroom, Ofc Voss was not seeing "dragging" Dylan out of the bathroom but he walked him out.

Amanda indicated they do not have surveillance video covering the outside western business wall. When asked if I could send her the Axon Capture Link to submit the surveillance video, Amanda said she could not do that. It would have to go through the corporate office. On 5/14/2025 at approximately 0930 hours, I was on duty and I was wearing my issued Tucson PD patrol uniform. I drove to this location in a marked patrol vehicle and I had with me my issued body worn camera. I had stopped at the Quik Trip located at 8530 E Broadway to use the restroom and to get a drink. When I walked into the restroom, I could see a male subject that I had recognized as the male subject who I had seen on the property earlier in the morning.

The businesses and the residents in this area have been heavily victimized by the drug addicted homeless community and the crimes associated to the drug addicted homeless community to include, but not limited to, criminal trespassing, criminal damage, open air drug use & drug sales, reckless burning, urinating & defecating in public, and general theft.

I had first contacted this subject when I was on my way to work at approximately 0510 hours on 5/24/2025 (in uniform/ no BWC as it is stored at the police station). I could see the male subject was sleeping in front of the Quik Trip (north side of the business, toward the western end of the business). I woke the subject up and told him to get off the property immediately. I advised him that if I saw him there again he would be arrested (or words to that effect). The male subject left the scene. I entered the store and spoke to the store manager, Amanda Valentine. I advised her of the male that was sleeping outside and told her I was able to get him to move along. She stated she had seen him sleeping in the same spot at approximately 0500 hours and she also told him to leave. He clearly did not leave.

When I spoke to the male subject as he was about to exit the restroom (5/14/2025 at approximately 0930 hours), I told him I remembered him from earlier in the morning and I advised him that this was a business. It was not his personal bed and it wasn't his personal restroom. I asked for his identification several times and he refused to provide it. At this time, it was my intention to officially trespass this person from the property. I was also entering the restroom with the intention of using the restroom, I was not expecting an encounter with a noncompliant trespasser.

I could see that the male subject was holding a large cloth bag over his right shoulder and I could not see his hand. He also had a two backpacks over his left shoulder (the back packs were attached together) and his left hand/arm was against the wall/ door jamb to the restroom at approximately the level of my face and head.

I tried to convince him to provide his ID but he would not comply. I pulled my handcuffs out of the pouch hoping that seeing the handcuffs would convince him to provide his ID but I was wrong. Pulling out my handcuffs is a tactic that I regularly use and most of the time I am able to gain compliance.

I decided that I was not going to be able to simply trespass this subject because he was too argumentative. I activated my BWC and I told him to put his hands behind his back. He refused to do as I ordered. I repeatedly told him to put his hands behind his back and I told him I would punch him in the face if he did not comply. He refused to follow my commands. I tried to take control of his wrist multiple times but he pulled away. The subject verbally escalated when I told him I would punch him in the face. He then stated the following throughout the contact:

"I'm not resisting arrest" as I first attempted control his left arm/ wrist

"You're threatening me on camera" when I told him I would "bust him in the mouth."

"No, let's go outside" when I ordered him to put his hands behind his back.

When I told him I would punch him in the face he stated "You'll punch me in the fuckin face! Yo! Chill the fuck out! Chill the fuck out! The fuck out!"

While I was attempting to gain control of his wrist/ arm, he broke free of my grip on his left wrist and he pulled away from me. He then attempted to throw a strike at me with his left hand (I don't believe that strike landed). He then yelled "Chill the fuck out! Chill the fuck out! Chill the fuck out!" I threw multiple punches at his face/head and body as well as a leg strike to his left leg. I believe I threw 3 strikes (closed fist). I threw 2 strikes to his face and head area and I believe 1 landed, the other did not. I threw another strike at his body and I believe that strike landed. The leg strike (kick) landed on the subject's left leg (common peroneal). I was then able to pull the subject to the floor and get on the radio to advise dispatch of my situation. I then handcuffed the subject behind his back. During this altercation I sustained a small scrape/abrasion on my right thumb. I do not remember how it happened.

He also stated the following:

As I was handcuffing him, I did not understand some of his statements but I did hear him say "You beat my ass for no reason."

"You started beating my ass you piece of shit!"

"...I'm not going to sit here and get my ass beat by a piece of shit cop! You want to punch me in handcuffs?! You mother fucker!"

"Beat my ass in the bathroom?! Who the fuck are you?!"

The subject continued to yell in the bathroom which was a smaller tiled space that made considerable echoes. I wanted to advise the responding officers that I had the subject detained and they could shut down any emergency response but the subject continued to yell. I even told him to "stop talking, I'm trying to get on the radio." The subject continued to yell. I then said "Dude, be quiet!" He continued to yell. It was clear to me that the subjects yelling was continuing to disrupt the business and it did not seem like he was going to stop yelling. I decided to move him out of the store. As I walked him out of the store, he stopped multiple times causing me to bump into him. He did this as he continued to yell at me. When I got him outside I attempted to put him in a seated position as he was physically non-compliant and I wanted him to be in a position of disadvantage. I attempted to pull him to the ground/ sidewalk but he was tensing up making it difficult to put him in a seated position. I pulled him backward and down and I was able to get him into a seated position. I did not want him to continue to fight or resist so I pushed him over on his side and I applied a pressure point technique (mandibular angle). This technique had the desired effect as I could feel that the subject allowed himself to relax. The pressure point was released at that time. As I was applying the pressure point, I believed I was pressing for approximately 1 second. After watching my body worn camera footage, I could see that I applied pressure for approximately 2-3 seconds.

No other force was used on this subject and when backup officers arrived, I stepped away.

The male was identified as Dylan Birdsong using his AZ ID card and his AZ MVD photo.

At the request of Quik Trip management, I advised Dylan that he was trespassed from this property. I made it very clear that Dylan was no longer welcome at this location and he will be arrested if returns to any part of this property. Dylan stated he understood and he would not return.

I provided Dylan with homeless outreach information (www.TPCH.net).

Dylan was arrested for criminal trespassing. He was cited and released at the scene.
