No identification was made, no NOK notification was possible.

Ofc. Thompson and I responded to the listed location in reference to a DOA call. It had been reported a body had been located in a wash, in a residential neighborhood

18th street runs east and west and the wash runs north to south. When I arrived the wash was flowing across 18th street from south to north, the body was on the west side of the wash, south of 18th. It was off the road, out of the wash next to the home at [REDACTED] E. 18th.

I contacted TFD Ladder 9 (Craig) he said when they arrived the body was floating in the wash, they were able to move near the home at [REDACTED] E. 18th. The body had trauma and bruising to it, the deceased was wearing only pants around the ankles. TFD had covered the body with a blanket due to the residential neighborhood, and a school day. It was raining and windy, the blanket was held down with bricks.

Craig said the trauma, injuries and bruising were consistent with a body being washed away and striking objects along the way. He had taken pictures of the initial scene, I sent him an AXON link to upload them. I took photographs, they were also uploaded into AXON.

Ofc. Thompson and I examined the body. It was an unknown age male, approximately 6-0 foot weighing 150 to 170 lbs. Lying on his back. He was naked with a pair of pants around the feet/ ankles. There were obvious signs of bruising and trauma to most of the body, the feet, legs, knees, torso, back, face and head. The hands were shriveled consistent with being in water for a prolonged time. The pants contained no identification.

I called the reporting party [REDACTED] he said he was driving his son to daycare [REDACTED] when he saw the body floating in the wash at 18th street. He said he did not stop because he had his son with him, not wanting him to see the body. Once he dropped off his son, he returned to the body and called 911.

I notified Sgt. Corcoran, and because of the trauma to the body I would be calling Sgt. Haynes, the TPD Homicide Sgt.

I called Sgt. Haynes and notified him of the incident. He advised me to have TPD Crime Scene respond and process the scene, and to have a MORPHO Identification done to try to identify the deceased. I told him of the TFD statement in regards to the trauma from being "washed" away. He then advised to have Pima County OME respond and examine the body, should any concerns be noted to notify him.

TPD Crime Scene Specialist Lorenz, responded and processed the scene, it was difficult because of the inclement weather. Due to the condition of the hands and fingers the MORPHO Identification DID NOT return an identification.

OME (Hairston #14) arrived and conducted his investigation, he found the condition of the body to be consistent with a "washed away" body.

Lorenz notified Sgt. Haynes of the OME outcome.

Ofc. Thompson (see his supplement) walked the wash and neighborhood looking for video and or witnesses.

No Next of kin notification was possible.

On 01/17/23, I assisted Ofc Sullivan (44537) on this call by photographing the water way and debris using AXON Capture. I spoke with neighbors if they had surveillance. [REDACTED] said his camera faces the direction the deceased was located but does not show much due to the low light however he would provide what he could. He said you could see the reporting party's vehicle stop and back up next to where the body was lying. I gave him the AXON Citizen link.

I spoke with [REDACTED] at [REDACTED] E 18th St. He said his camera footage already erased itself but he saw the body on his camera lying where it was found at approximately 0530 hours.

The debris against the poles nearby suggest the water had been running at least around three feet or more.

After running the decedent's fingerprints through the system a "NO HIT" returned on the male decedent, I contacted Sgt. Haynes #41537 (Tucson Police Department Homicide) and advised him of my findings.

On 01/17/2023 Sgt Haynes emailed me in reference to this case. The deceased individual in this case could not be identified as he had no identification on him, was found in a wash and due to the exposure his body had experienced, fingerprints with Morpho could not be read. Sgt Haynes asked that I track this report to log who the deceased individual is and do next-of-kin notification if need be.

On 01/23/2023 Trevis Hairston with PCOME emailed Sgt Haynes and stated that they had been able to identify the deceased via an FBI fingerprint hit. The individual was identified as Fredrick [REDACTED] job [REDACTED]. His email stated:

So, we received an FBI fingerprint hit which comes back to a Fredrick [REDACTED] D.O.B. [REDACTED].

I looked up some medical history for Fredrick and found the first names spelled as Frederick too. The SSN would be [REDACTED]. When I stated that the decedent had medical hardware in his left elbow the medical records I could find document left elbow fracture.

Trevis requested that I send him a photo ID of Fredrick. In doing so Dr. Chen was able to positively identify the decedent as Fredrick.

I then began working on finding Next-of-kin. I performed a check in our local police databases and did not find any information in regard to family. LInX, TLOxp, and Accurant did not give me much more information. I did discover that [REDACTED] was possibly a [REDACTED] (dob [REDACTED]) and [REDACTED] was [REDACTED]. I did an obituary search for [REDACTED] and found that [REDACTED] had also passed. It listed Fredrick as [REDACTED] with [REDACTED]. I found a phone number for [REDACTED] of 520-[REDACTED] and left him a message. I also left message for [REDACTED] at [REDACTED] [REDACTED] at [REDACTED] and [REDACTED] at 520-[REDACTED]. [REDACTED] returned my call shortly thereafter and confirmed he was [REDACTED]. He said that Fredrick had been homeless for some time and had been sporadic with his contact with them. He was saddened to hear the news. I provided him with the contact information for PCOME and our case number. [REDACTED] information was also provided to Trevis in the event they would need to contact him. This concludes my involvement.
