On 08/22/2023 I responded 1920 N 1st reference suspicious activity. The complainant was reporting that a Hispanic male, black clothing, green duffel bag was hitting himself and hiding under vehicles in the parking lot.

Upon arrival, I made contact with who advised that she saw the suspect hitting himself and "acting crazy". She pointed to a male matching the description given on the east side of the parking lot and stated that he is the suspect. I detained him without incident and he identified himself as Damyan Luviano. I offered him medical treatment and he refused.

A records check showed that he had a warrant for a sex offender violation and another alert for a sex offense violation under cases 2110050248, 2301210163, and 2305230040. Additionally, he had 3 misdemeanor warrants from the Tucson Police Department. The warrants were confirmed.

I transported him to jail. Medical staff at the jail advised that Damyan's vital signs were normal, he did not claim to have swallowed any narcotics but he was being rejected because he "is high". I advised them that he is being booked for multiple sex offense violations and they replied that he would still be rejected stating "it's not our call".

Sgt Jove (53366) and Sgt Sullivan (34971) were advised. Sgt Jove advised we would not keep him in custody for a medical clearance.

I transported him to St Mary's Hospital and released him from custody there.
