   Commander, the appropriate Bureau Chief, the Chief of Police, or designee)

Unless approved by the OPS Commander, Bureau Chief, Chief of Police, or designee, the following are not accepted:

- · Anonymous complaints alleging minor violations
- o Complaints alleging minor violations where the incident occurred more than 180 days ago

#### Arizona state law requires the following notice:

Pursuant to section 13-2907.01, Arizona Revised Statutes, it is a class 1 misdemeanor to knowingly make to a law enforcement agency a false, fraudulent or unfounded report or statement or to knowingly misrepresent a fact for the purpose of interfering with the orderly operation of a law enforcement agency or misleading a peace officer.
