On November 6, 2024, at 0852 hours while on patrol at

I responded to the B concourse for a report of a passenger with a firearm in their carryon bag that was located in the lane 1 X-ray. Officer Derek Tyra responded initially, but due to a conflict of interest, I took over the call. Upon arrival I was advised that TSA Agent, Ricardo Chavarria, was the X-ray tech who discovered the firearm in a backpack brought in by the passenger identified as Christopher Nanos. I spoke with TSA Supervisor Francis Wodiuk who advised they were complete with all their screening checks. I collected the backpack and the passenger and moved them to the private screening room. I asked where in the bag the firearm was located and Mr. Nanos stated in the large zippered pocked. I located the loaded Glock firearm with 5 live rounds in the magazine and one in the chamber and rendered the firearm safe. The firearm was in a hard plastic holster. The firearm was not artistically or purposely concealed. Mr. Nanos' name and date of birth were run through Communications and returned negative for wants or warrants. The serial number to the firearm (ZMY652) was also run for wants and returned negative. I read Mr. Nanos his Miranda rights from my department handbook at 0912 hours (Y/Y). When asked if he had packed his own bag he stated yes. When asked if it was his firearm in the backpack he stated yes. I called my chain of command as well as Department of Homeland Security Agent Dave Lutz and Federal Bureau of Investigations Agent Eric Brantley and advised them of the situation.

Mr. Nanos was escorted off the concourse to place his firearm in his vehicle, and he was rebooked to fly out at a later time.
