Lt. Graves, after speaking with you last week I received the documentation, including your personal report you provided Captain Duffy. Again, I apologize you were involved in this matter and appreciate your patience while we work towards a resolution. I spoke with Mrs. Preston from your HOA and City Risk Management in an effort to resolve this matter last week. As such it will take some time to work with the aforementioned parties to come to an amenable resolution. I wanted to address your OR for the time being

Paragraph 4~

The city employee collision with the reported gate was investigated under OPS 16-0250. The employee in that investigation self reported the incident, you were clearly not the employee involved in the matter. Your name has been cleared with the HOA (attached email) in 011917. The HOA has been provided information on how to get a copy of the OPS investigation.

### Paragraph 5~

This situation is far more complicated than your very basic, HOA provided information of the damage as you describe. I will work with all parties involved to find a reasonable solution to this incident. It is in fact "ridiculous" as you described that the HOA drove around and deemed you involved in this matter solely based on you having a City vehicle in your driveway.

As far as your request in the final sentence of you OR, this incident will be resolved as quickly as possible through the City Risk Management and the City Attorneys Office working with the Tangerine Crossing HOA. The resolution will not be immediate and potentially not to your satisfaction as you demand in the OR, this being complicated by the fact as you noted in your OR that you are a larger resident of the neighborhood and pay HOA dues for property maintenance. As with all insurance claims often both parties have to negotiate a reasonable repair cost for damage caused by an accident, this situation is no different.

All of the information you provided Captain Duffy will be memorialized in the OPS 16-0250 investigative file. When this matter is resolved, and or deemed closed by City Risk Management, I will also create a memorandum to file for closure purposes. Details:

On January 18, 2017 I received an email from Charlotte E. Preston, Community manager of the Tangerine Crossing Homeowners association; I live in this neighborhood and have for several years. The email accused me of damaging one of the neighborhood gates with my work vehicle. It additionally stated that the City was not going to pay the damage and that I would be responsible for the repairs, which were claimed to exceed 7 thousand dollars.

Later that evening I was able to speak with Ms. Preston and explain to her that I had no idea what she was talking about. I told Ms. Preston that I did work for the City of Tucson but that I never hit any of the entry gates with my work vehicle. Ms. Preston said that this damage occurred around June 23, 2016 and that she had spoken with a Capt. Kasmar reference the incident.

I asked Ms. Preston why they thought I was responsible, she said that she was never given a name of the City employee that caused the damage. Furthermore, when the City just recently denied the claim for damages they saw my marked patrol vehicle in front of my home. The assumption was then made, since I was a City employee, that I must be the one who caused the damage.

I was in no way responsible for the aforementioned damage and was actually out of town, in Pine Top, the week of June 20, 2016. I respectfully request that the Department look into this matter and clear my name with the Tangerine Crossing HOA. Once the investigation is complete I would like a letter drafted to the HOA indicating that I was not the City Employee, of whom D/C Kasmar was speaking. I would additionally request that the HOA be provided with the name of the employee responsible.

I found it to be very surprising that Ms. Preston did not know who, by name, actually caused over 7 thousand dollars damage to private property. I am a member of the Tangerine Crossing community, and as such, am partially responsible for any repairs that are not covered by the City of Tucson or the responsible employee. That Ms. Preston had to send security guards out to locate an unsuspecting City of Tucson employee, to hold responsible for this damage, is ridiculous.

If the Tangerine Crossing HOA continues to believe that I am the responsible party it is within their legal right to place a lean against my property for the damages. I respectfully request that this legal matter be resolved, to my satisfaction, immediately.

### **BWC ACTIVATED BY OFFICER NGUYEN #454**

On January 19th, 2017 at 1334 hours dispatch advised Charolette Preston, the reporting party had contacted police wishing to file a report reference a past occurred criminal damage claim. I spoke with Charolette via the telephone, after speaking with her we decided to meet at Tangerine Rd/ Tangerine Crossing, the location where the incident occurred.

Upon arrival I spoke with Charolette. She advised that on June 23rd, 2016 she was contacted by a Captain Kasmar who informed her that an unnamed Tucson Police Department (TPD) officer had hit the entry gate located at Tangerine and Tangerine Crossing with their patrol vehicle. Charolette stated Captain Kasmar informed her the individual had informed his chain of command and that the information had been forwarded to TPD's risk management department. Charolette advised that from June of 2016 to December of 2016 she had multiple communications with Captain Kasmar via email. Charolette stated she told by Captain Kasmar to get estimates for the repairs needed. Charolette advised she received estimates from two different companies, Antech Corporation quoted her \$10,500 to repair the gate. The second company, Eagle Gateworks Inc, quoted \$7,306.70 to repair the gate. Charolette was advised that the information regarding the incident had then been forwarded to risk management. Charolette advised that on December 12th, 2016 she received an email from Martha Castro with the forms necessary to submit her claim to the claims department. Charolette stated that she returned the forms via regular mail to the City of Tucson on December 21st.

Charolette advised that on December 27th, 2016 she received notice from the City of Tucson that she had missed the 180 day deadline to submit her claim. The notice advised that since she missed the

deadline the city was unable to consider her claim. At the time Charolette stated she was unaware of Arizona Revised Statute 12-821.01, which pertains to the 180 day deadline.

Charolette stated that if the City of Tucson was not going to pay for the damages she needed to find out which officer had hit the gate, because they would be responsible. Charolette advised that another TPD officer, Lieutenant Graves, who also lives in the neighborhood had advised Charolette that she should contact the Marana Police Department and make a report with us reference the damaged gate.

Lt. Graves, after speaking with you last week I received the documentation, including your personal report you provided Captain Duffy. Again, I apologize you were involved in this matter and appreciate your patience while we work towards a resolution. I spoke with Mrs. Preston from your HOA and City Risk Management in an effort to resolve this matter last week. As such it will take some time to work with the aforementioned parties to come to an amenable resolution. I wanted to address your OR for the time being.

### Paragraph 4~

The city employee collision with the reported gate was investigated under OPS 16-0250. The employee in that investigation self reported the incident, you were clearly not the employee involved in the matter. Your name has been cleared with the HOA (attached email) in 011917. The HOA has been provided information on how to get a copy of the OPS investigation.

### Paragraph 5~

This situation is far more complicated than your very basic, HOA provided information of the damage as you describe. I will work with all parties involved to find a reasonable solution to this incident. It is in fact "ridiculous" as you described that the HOA drove around and deemed you involved in this matter solely based on you having a City vehicle in your driveway.

As far as your request in the final sentence of you OR, this incident will be resolved as quickly as possible through the City Risk Management and the City Attorneys Office working with the Tangerine Crossing HOA. The resolution will not be immediate and potentially not to your satisfaction as you demand in the OR, this being complicated by the fact as you noted in your OR that you are a larger resident of the neighborhood and pay HOA dues for property maintenance. As with all insurance claims often both parties have to negotiate a reasonable repair cost for damage caused by an accident, this situation is no different.

All of the information you provided Captain Duffy will be memorialized in the OPS 16-0250 investigative file. When this matter is resolved, and or deemed closed by City Risk Management, I will also create a memorandum to file for closure purposes. I will make sure you receive a copy of said memorandum for your records. Please provide me a copy of any additional correspondence you have with the HOA specific to this situation. Thank you,

Details:

On January 18, 2017 I received an email from Charlotte E. Preston, Community manager of the Tangerine Crossing Homeowners association; I live in this neighborhood and have for several years. The email accused me of damaging one of the neighborhood gates with my work vehicle. It additionally stated that the City was not going to pay the damage and that I would be responsible for the repairs, which were daimed to exceed 7 thousand dollars.

Later that evening I was able to speak with Ms. Preston and explain to her that I had no idea what she was talking about. I told Ms. Preston that I did work for the City of Tucson but that I never hit any of the entry gates with my work vehicle. Ms. Preston said that this damage occurred around June 23, 2016 and that she had spoken with a Capt. Kasmar reference the incident.

I asked Ms. Preston why they thought I was responsible, she said that she was never given a name of the City employee that caused the damage. Furthermore, when the City just recently denied the claim for damages they saw my marked patrol vehicle in front of my home. The assumption was then made, since I was a City employee, that I must be the one who caused the damage.

I was in no way responsible for the aforementioned damage and was actually out of town, in Pine Top, the week of June 20, 2016. I respectfully request that the Department look into this matter and clear my name with the Tangerine Crossing HOA. Once the investigation is complete I would like a letter drafted to the HOA indicating that I was not the City Employee, of whom D/C Kasmar was speaking. I would additionally request that the HOA be provided with the name of the employee responsible.

I found it to be very surprising that Ms. Preston did not know who, by name, actually caused over 7 thousand dollars damage to private property. I am a member of the Tangerine Crossing community, and as such, am partially responsible for any repairs that are not covered by the City of Tucson or the responsible employee. That Ms. Preston had to send security guards out to locate an unsuspecting City of Tucson employee, to hold responsible for this damage, is ridiculous.

If the Tangerine Crossing HOA continues to believe that I am the responsible party it is within their legal right to place a lean against my property for the damages. I respectfully request that this legal matter be resolved, to my satisfaction, Immediately.

On January 19th, 2017 at 1334 hours dispatch advised Charolette Preston, the reporting party had contacted police wishing to file a report reference a past occurred criminal damage claim. I spoke with Charolette via the telephone, after speaking with her we decided to meet at Tangerine Rd/ Tangerine Crossing, the location where the incident occurred.

Upon arrival I spoke with Charolette. She advised that on June 23rd, 2016 she was contacted by a Captain Kasmar who informed her that an unnamed Tucson Police Department (TPD) officer had hit the entry gate located at Tangerine and Tangerine Crossing with their patrol vehicle. Charolette stated Captain Kasmar informed her the individual had informed his chain of command and that the information had been forwarded to TPD's risk management department. Charolette advised that from June of 2016 to December of 2016 she had multiple communications with Captain Kasmar via email. Charolette stated she told by Captain Kasmar to get estimates for the repairs needed. Charolette advised she received estimates from two different companies, Antech Corporation quoted her \$10,500 to repair the gate. The second company, Eagle Gateworks Inc, quoted \$7,306.70 to repair the gate. Charolette was advised that the information regarding the incident had then been forwarded to risk management. Charolette advised that on December 12th, 2016 she received an email from Martha Castro with the forms necessary to submit her claim to the claims department. Charolette stated that she returned the forms via regular mail to the City of Tucson on December 21st.

Charolette advised that on December 27th, 2016 she received notice from the City of Tucson that she had missed the 180 day deadline to submit her claim. The notice advised that since she missed the

deadline the city was unable to consider her claim. At the time Charolette stated she was unaware of Arizona Revised Statute 12-821.01, which pertains to the 180 day deadline.

Charolette stated that if the City of Tucson was not going to pay for the damages she needed to find out which officer had hit the gate, because they would be responsible. Charolette advised that another TPD officer, Lieutenant Graves, who also lives in the neighborhood had advised Charolette that she should contact the Marana Police Department and make a report with us reference the damaged gate.

Pictures of the gate where taken and later placed into evidence at the Marana Police Substation, located at 5100 W Ina.

On January 20th, 2017 I attempted to contact Charolette via telephone, with negative results. I did however leave a voice mail informing Charolette that a report had been written documenting the incident, and our command staff would be contacting Deputy Chief Kasmar reference the incident.

### Details:

On May 5, 2016 at approximately 1630 hours Assistant Chief Ramon Batista was entering a private gated community when he collided with an automated metal driveway gate. The collision caused damage to both his city assigned vehicle and the gate he collided with. There were no injuries as a result of the on duty private property collision and the city vehicle was drivable.

### **Investigation**

- I was the sole investigator and first level of review as assigned by Chief Chris Magnus.
  - I identified the Home Owners Association as Tangerine Crossing HOA, C/O AAM, LLC for the damaged gate. Their corporate address is:
    - 1600 West Broadway Road, Suite 200, Tempe, AZ., 85282.
    - My point of contact for this company was Charlotte Preston, 520-477-0251. Cpreston@aamaz.com.
    - I contacted Ms. Preston and advised her of the collision. After researching the property logs she determined that a report had not been made of recent damage to the gate, nor did she have any pending complaints that the gate was not functioning properly (although the residents in the neighborhood indicated on Facebook there had been intermittent issues with the gate not opening properly).
    - She facilitated getting an estimate to repair the gates.
- I took photographs and inspected the gates on June 22, 2016 at 0620 hours and the gate had not been repaired.
  - o During my inspection I cycled the gates with the pin pad several times.
    - I took photographs to show damage I located on the eastern northbound gate.
      - Wear in the red reflector tape on the lower part of the eastern gate frame.
      - The offset of the two gates caused by the bent gate tomar (the arm of the gate that attaches the gate to the motor) approximately 4 inches off from center.
      - The bent tomar on the eastern gate causing the misalignment.
      - The western northbound undamaged gate tomar.
  - It should be noted that the damage to the gate would go unnoticed by most people.
    - I have over 20 years of fabricating and welding experience, to include gate fabrication.
    - I received an initial estimate repair bill of \$1,439.00 to repair the damaged tomar on July 19, 2016.

- Through several months of emails I received a new repair estimate of \$10,500 to replace both gate electric motors. When I questioned the significant cost increase she provided additional paperwork to support the increase several weeks later.
- I interviewed AC Batista on September 7, 2016. I provided him an administrative investigation notice prior to asking him any questions. He declined representation.
- AC Batista provided the information listed in this report.
- On the day of the incident Assistant Chief Batista worked 0800 to 1600 hours.
- He left his office at approximately 1540 hours to pick up his daughter from school due to an unexpected schedule change.
  - o He provided verbal notification to acting Chief Carla Johnson prior to leaving the office.
- After picking his daughter up at 1436 North Campbell, they drove to their residence.
- He was driving City vehicle 0264.
  - o 2007 Ford Crown Victoria.
  - Titanium in color.
  - o License plate G-262EY.
  - o Vehicle Identification Number 1FAFP71W97X111634.
- He arrived to his gated community, making a northbound turn onto North Tangerine Crossing Drive from West Tangerine Road.
- He traveled approximately 60 yards and came to a complete stop at the gate pin pad. He entered his gate code and when he observed the west gate start to open he proceeded north. It should be noted there are two matching steel constructed square tubing gates.
  - o The gates are approximately 30 yards to the North of the pin pad.
  - o The gates at rest come together over the center of a one way entrance road.
  - o Both gates have independent motors to open them to the south, which is towards the driver as you enter the private driveway of the Tangerine Crossing community.
  - o There is a break in the median between the pin pad and the gates.
  - There are a second set of gates for a one way exit out of the community.
- He was traveling at an estimated 5 mph when the collision occurred.
- He noted that when he observed the western northbound gate start to open, he started driving. He failed to
  notice the eastern gate did not move and he struck it. He stated he was going around 5 mph, and less than
  10 mph when he made contact with the gate.
- He stated after striking the gate he realized it did not open with the other gate.
- Both occupants of the vehicle were wearing their seatbelt during the collision.
- Assistant Chief Batista was not on his cell phone when the incident occurred.
- He immediately notified me, Office of Professional Standards Lieutenant Matt Ronstadt and Captain Paul Sayre via text message. He also notified acting Chief of Police Carla Johnson and included photographs of the damage.
  - The collision was documented under OPS 16-0250 and case number 1611160572.
- Photographs documenting the damage to the City vehicle were memorialized in the OPS investigative file.

### **Findings**

The investigation supports that this private property collision was preventable. Based upon the investigation, Assistant Chief Batista committed the following General Order violations:

On 05/05/16 at approximately 1630 hours I was driving my Department issued, 2007 Ford Crown Victoria police car. As I arrived at my housing community near the intersection of W. Tangerine Rd and N. Thornydale, I activated the security gate and proceeded forward, I took for granted that both gates would open, however one gate malfunctioned and I collided with it. My vehicle slid under the metal gate and caused damage to the passenger's side/hood of the car.

I was wearing my seatbelt during the collision and my speed was approximately 5 mph. I notified my direct supervisor, acting chief of police AC, Carla Johnson of the incident. The following morning I took photographs of the car and the gate – attached.






### Please Complete Vehicle Damages Diagrams

# Notes/Narratives

On May 5, 2016 at approximately 1630 hours Assistant Chief Ramon Batista was entering a private gated community when he collided with an automated metal driveway gate. The collision caused damage to both his city assigned vehicle and the gate he collided with. There were no injuries as a result of the on duty private property collision. The city vehicle was drivable, and the jurisdictional law enforcement agency was not called to the scene due to the non-injury private property collision.

On May 5, 2016 Assistant Chief Batista worked 0800 to 1600 hours. He was driving his assigned City vehicle 0264, 2007 Ford Crown Victoria, Titanium in color, license plate G-262EY, Vehicle Identification Number 1FAFP71W97X111634. He arrived to the Tangerine Crossing gated community, making a northbound turn onto North Tangerine Crossing Drive from West Tangerine Road. He traveled approximately 60 yards and came to a complete stop at the gate pin pad. He entered his gate code and when he observed the west gate start to open he proceeded north. It should be noted there are two matching steel constructed square tubing gates. The gates are approximately 30 yards to the North of the pin pad. The gates at rest come together over the center of a one way entrance road. Both gates have independent motors to open them to the south, which is towards the driver as you enter the private driveway of the Tangerine Crossing community. There is a break in the median between the pin pad and the gates. There are a second set of gates for a one way exit out of the community. He was traveling at an estimated 5 mph when the collision occurred. His daughter (minor) was in the vehicle wit him at the time of the collision, both occupants of the vehicle were wearing their seatbelts during the collision, and they were both uninjured. Assistant Chief Batista was not on his cell phone when the incident occurred. The collision was also documented under Office of Professional Standards investigation 16-0250.

The property management company is Tangerine Crossing HOA, C/0 AAM, LLC., 1600 West Broadway Road, Suite 200, Tempe, AZ., 85282. The point of contact for this company is Charlotte Preston, 520-477-0251, Cpreston@aamaz.com. I contacted Ms. Preston and advised her of the collision. After researching the property logs she determined that a report had not been made of recent damage to the gate, or any pending complaints that the gate was not functioning properly. She facilitated getting an estimate to repair the gates. I received an initial repair bill of \$1,439.00 to repair the damaged tomar on July 19, 2016. Through several months of emails I received a new repair estimate of \$10.500 to replace both gate electric motors. I took photographs and inspected the gates on June 22, 2016 at 0620 hours. During my inspection I cycled the gates with the pin pad several times. I took photographs to show damage I located on the eastern gate, noting a tear in the red reflector tape on the lower part of the eastern gate frame, the offset of the two gates caused by the bent gate tomar (the arm of the gate that attaches the gate to the motor) approximately 4 inches off, the bent tomar on the eastern gate, the western undamaged gate tomar. I interviewed AC Batista on September 7, 2016. It should be noted that Chief Batista inspected the gate where he made contact with is vehicle and there was no damage to the metal structure of



- The bent gate arm on the right forced the top plate of the operator to bend/disengage needing repair

- The right operator tells the left operator to open the gate

Good Morning Captain Kasmar,

Sorry this information has been slow in coming to you regarding why the cost of repairing the operators at the gate are so expensive.

- The bent gate arm on the right forced the top plate of the operator to bend/disengage needing
- The operators (both sides of the gate one operator for each gate) are electronically connected
- The right operator tells the left operator to open the gate
- When the damage was done to the arm on the right gate, it bent the operator top section which causes alignment of the operator to be out of sync - it is a matter of a short time when they both will fail
- When one operator goes down, both need to be rebuilt
- The current operators are no longer available so the only option is to rebuild them cost is slightly over \$10K
- To replace them both with a new system is over \$40K.

I hope this information is what you need to move forward.



#### **BWC ACTIVATED BY OFFICER NGUYEN #454**

On January 19th, 2017 at 1334 hours dispatch advised Charolette Preston, the reporting party had contacted police wishing to file a report reference a past occurred criminal damage claim. I spoke with Charolette via the telephone, after speaking with her we decided to meet at Tangerine Rd/ Tangerine Crossing, the location where the incident occurred.

Upon arrival I spoke with Charolette. She advised that on June 23rd, 2016 she was contacted by a Captain Kasmar who informed her that an unnamed Tucson Police Department (TPD) officer had hit the entry gate located at Tangerine and Tangerine Crossing with their patrol vehicle. Charolette stated Captain Kasmar informed her the individual had informed his chain of command and that the information had been forwarded to TPD's risk management department. Charolette advised that from June of 2016 to December of 2016 she had multiple communications with Captain Kasmar via email. Charolette stated she told by Captain Kasmar to get estimates for the repairs needed. Charolette advised she received estimates from two different companies, Antech Corporation quoted her \$10,500 to repair the gate. The second company, Eagle Gateworks Inc, quoted \$7,306.70 to repair the gate. Charolette was advised that the information regarding the incident had then been forwarded to risk management. Charolette advised that on December 12th, 2016 she received an email from Martha Castro with the forms necessary to submit her claim to the claims department. Charolette stated that she returned the forms via regular mail to the City of Tucson on December 21st.

Charolette advised that on December 27th, 2016 she received notice from the City of Tucson that she had missed the 180 day deadline to submit her claim. The notice advised that since she missed the

deadline the city was unable to consider her claim. At the time Charolette stated she was unaware of Arizona Revised Statute 12-821.01, which pertains to the 180 day deadline.


Charolette stated that if the City of Tucson was not going to pay for the damages she needed to find out which officer had hit the gate, because they would be responsible. Charolette advised that another TPD officer, Lieutenant Graves, who also lives in the neighborhood had advised Charolette that she should contact the Marana Police Department and make a report with us reference the damaged gate.


