#### **Attention Exhibitors**

These shows will be judged and run by the Show Rules of the Australian Shepherd Club of America. Dogs must be ready for judging. Neither the club nor the chairman will be responsible or obligated to furnish any services for notifying exhibitors or their agents of class judging. Entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the show committee. Entry fees will only be refunded if the refund request is received before the pre-entry closing date, no entry fee will be refunded if the show cannot be opened or completed by reasons of riots, civil disturbances, fire, Acts of God, or public emergency. The show-giving club, the Show Chairman, their agents, officers, and/or committee shall assume no responsibility for injury to children. Judges may be substituted. All dogs must be leashed or crated at all times, except when competing. No electrical and/or mechanical training devices will be permitted on the show grounds. Please clean up after your dogs. No bitches in season permitted IN THE BUILDING, even in pants, in or near the obedience or rally ring. Bitches in season are not permitted to enter these trials. Class Conflicts: Please notify the appropriate ring official of your conflict. For the safety of your dogs and others all dogs must have current vaccinations against rabies, distemper/parvo, you are asked to bring a copy of the rabies certificate with you.

No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

## **OBEDIENCE & RALLY SPECIFICATIONS**

As of 1/1/1993, dogs of any registry may enter obedience classes in ASCA sanctioned Shows. Titles will be issued upon completion of requirements. Dogs must show proof of registration with entry. Only dogs with ASCA CD are permitted to enter GN, CDX or ODX; an ASCA CDX or ODX is required to enter Utility classes. NO EXHIBITION ONLY. For complete rules see ASCA's web site: <a href="http://www.asca.org">http://www.asca.org</a>.

Note: These Obedience trials will NOT permit entries, or runs, by any Obedience Bitch In Season (OBIS). Any handler whose bitch comes into season, is eligible for a refund of her entry fees upon notification of the Trial Secretary/Show Coordinator. Substitutions are permitted for dogs that the handler owns or co-owns, upon handler request to the Trial Chair.

Another note: Optional Titling classes <u>can</u> be entered by the same dog in the regular titling classes! Please verify entry eligibility as listed in the ASCA Obedience Rulebook, in regards to Beginner Novice, Graduate Novice, or Versatility.

Yet another note: Remember, Rally does not permit <u>entry</u> in the next higher class level until the title has been earned. All trials WILL permit move ups and move overs (up to the next level, or A to B to C classes) as applicable.

Please don't forget to **include your JUMP HEIGHTS** if your dog is entered in a class with jumps! And don't forget to note on your entry form,if your dog is entered in Utility B and CDX or ODX B, if points go towards the OTCH or the OTCH-O.

The ADOG show site and building has classes in session the Thursday evening before the trial, November 8, until 9pm. Handlers are welcome to bring their equipment for storage in advance; the show site will be open Friday morning around 8am for complete setup. Saturday and Sunday, the show site will be open by 7:15am for Day of Show entries in both sports, in addition to any move ups/ move overs for titles earned over the weekend. Equipment can remain in place for the handler's use up to the completion of all trials on Sunday November 11.

### **OBEDIENCE & RALLY SPECIFICATIONS**

The trials are open to all breeds. All non-ASCA registered dogs must have an ASCA QTracking Number to enter this trial. For instructions and information on obtaining a tracking number, please see the ASCA website at <a href="https://www.asca.org">www.asca.org</a>. Handler is responsible for his dog and must keep the dog under his control at all times. Dogs must be on leash when not in the ring. Handler will be responsible for any injury caused by their actions or that of their dog. Crating is allowed in the building, but metal crates must be placed on towels or blankets to protect the flooring. No bitches in season permitted to enter either sport, or even permitted inside the building, even in pants.

### **FACILITY**

ADOG Training Facility is a 5,800 square foot air conditioned and fully matted indoor facility for your dog's safety. Crating space is available (please put pads/towels under crates to prevent damage to matting.) **NO EXERCISE PENS PERMITTED INDOORS. ABSOLUTELY NO GROOMING OR CHALK IS PERMITTED IN THE BUILDING!!** There is a large parking area with plenty of room for RV parking overnight, but there are no hook-ups. Please pick up after your dog in all areas. Dogs must be on leash at all times, including potty breaks and exercise. All children on site must be carefully supervised at all times, for their safety.

## **AWARDS**

**Obedience:** Ribbons awarded for 1st through 4th place. Green Q ribbons will be awarded for qualifying scores. Rosettes awarded for HIT, High Combined, HIT Aussie, HIT Other Breed, and HIT Junior for each trial.

**Rally:** Ribbons awarded for 1<sup>st</sup> through 4<sup>th</sup> place. Green Q ribbons for qualifying scores, XQ ribbons for teams qualifying with scores of 195 and up. Rosettes awarded for HIT, HIT Aussie, HIT Other Breed, HIT Junior, and High Combined from Masters B/Excellent B.
