GAASC will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show site. In such case, no refund of fees paid will be made. GAASC reserves the right to refuse any entry including anyone who is not in good standing with ASCA or GAASC. No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee.

GAASC requires that you pick up after your dog at the show site and the hotel. Any complaints made by the hotel could result in loss of future trial privileges. All dogs must be on lead. No parking in fire lanes.
