ABSOLUTELY NO GROOMING IN THE BUILDING. All classes will be held indoors, on mats with ring gating. Crating indoors is available on a limited basis. Please use a towel or blanket under your crate to protect the flooring. No ex-pens allowed in the building. There is a large parking area with plenty of room for RV parking, but no overnight parking. Please pick up after your dog in all areas. Dogs must be on leash at all times. All dogs must be removed from the property after completion of the show each day. All children on site must be carefully supervised at all times, for their safety. There are no food vendors, but we will have lunch snacks available for everyone. There are no restaurants close by, please plan accordingly.

GAASC will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee will be asked to leave the show site. In such case, no refund of fees paid will be made. GAASC reserves the right to refuse any entry including anyone who is not in good standing with ASCA or GAASC. No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee.

GAASC requires that you pick up after your dog at the show site and the hotel. Any complaints made by the hotel could result in loss of future trial privileges. All dogs must be on lead. No parking in fire lanes.
