WHEREAS, the Sac and Fox Tribal Code Section 5-2308, states that the Chief Judge of the Trial Court shall exercise administrative supervision over the Trial Court and Judges thereof; and,

WHEREAS, it is important that a Court schedule be set for the Trial Court and Judges in the interest of judicial efficiency and organization;

THEREFORE, to the extent reasonable and fair, the Court hereby adopts the following Court Schedule to guide Court staff and Court users, absent good cause to the contrary:

CIVIL COURT	All Civil cases, including Small Claims Court, are typically scheduled by the Clerk of Court on Monday-Friday for 10:00AM - 4:00PM. CIVIL Domestic Violence matters Pursuant to Title 24: Monday-Wednesday at 9:30AM. (these are NOT Criminal Domestic charges)
CRIMINAL COURT	Criminal Citations: Monday-Wednesday at 9:00AM. In-Custody Arraignment/Bond Hearings/Pre-Trial Conferences: 9:00 AM. No hearings on weekends or holidays unless Defendant is in custody and will not meet the 72-hour deadline for appearing before a Judge Jury Trials: Generally the last Tuesday of the month.
JUVENILE COURT	Monday-Friday at 1PM.
TRAFFIC COURT	Tuesday at 9:00AM.
HOLIDAYS & ADMINISTRATIVE CLOSURE	Unless otherwise scheduled, the Meskwaki Tribal Court will be closed on the same Holiday and Administrative Closure times observed by the Sac & Fox Tribal Offices. Memorandum to issue annually from Clerk of Tribal Court regarding Holiday dates observed.

This Court Schedule shall take effect May 24, 2018.
