## ADMINISTRATIVE ORDER

Order No.: AO-2024-010

In re: Building Closure (Holiday)

WHEREAS, the establishment of an "an integrated judicial department to be known as the Sac & Fox Tribe of the Mississippi in Iowa Tribal Court and consisting of a Court of Appeals, a Trial Court, and such lower or intermediate courts as the Tribal Council deems necessary" is set forth in the DISPUTE RESOLUTION CODE, at Title Five, art. II, § 5-201; and

WHEREAS, the Chief Justice "shall exercise the Court of Appeals' administrative supervision over all the Trial Courts and Judges" and "... may make administrative... orders" pursuant to Title Five, art. II, §§ 5-2209(a); 5-2210(b); and

WHEREAS, the Court of Appeals shall have the power and duty to "promulgate rules and policies regulating the internal and administrative operations of the Tribal Court and its clerks and staff" pursuant to Title Five, art. II, §5-2207(d); and

WHEREAS, tribal operations are closed on Thursday, July 4, 2024 and Friday, July 5, 2024 for holiday observance;

NOW THEREFORE, BE IT RESOLVED THAT THE CHIEF JUSTICE ENTERS THE FOLLOWING ADMINISTRATIVE ORDER EFFECTIVE UPON THE DATE OF SIGNATURE:

> Meskwaki Tribal Court shall be closed for business on Thursday, July 4, 2024 and Friday, July 5, 2024. Court operations shall resume at 8 a.m. CST on Monday, July 8, 2024. Any statutorily-required criminal proceedings shall occur on Saturday, July 6, 2024 at 11 a.m. CST. The Judiciary shall extend all case filing deadlines of July 4, 2024 and July 5, 2024 to July 8, 2024.
