2025 Meskwaki Tribal Court Scholarship

The Meskwaki Tribal Court has created a scholarship opportunity to assist those Meskwaki students with strong leadership qualities, a commitment to serve the Meskwaki community, and proof of academic excellence to help offset the cost of college tuition, room and board and necessary supplies such as books. The Court encourages all students to further their education and become strong advocates for their tribal people, especially those with a future interest in a law related career such as advocates, attorneys, judges, court clerks, paralegals, law enforcement officers, and any other community safety or social services related positions.

The Meskwaki Tribal Court has established a one-time scholarship for **one \$500.00 scholarship to be awarded to a Meskwaki student graduating from Meskwaki High School or South Tama High School.**

Eligibility

To be eligible for this scholarship opportunity, the Applicant must be an enrolled member OR descendant of the Meskwaki Nation who is a graduating high school senior during the 2024-2025 academic school year from Meskwaki High School or South Tama High School and pursuing a post-secondary course of study (2-year or 4-year program).

Criteria for Selection

1. Applicant must be an enrolled member OR a descendant of the Meskwaki Nation who is a graduating high school senior at Meskwaki High School or South Tama High School.
2. Applicant must have a GPA of 2.5 or higher.
3. Applicant must be admitted to an approved college, university, trade and technical school and pursuing any degree of study.
4. Applicant must submit a completed application form and written essay.
5. Preference will be given to applicants who express a future interest in a law-related career with a strong commitment to serve the Meskwaki community, but any chosen fields can apply.

PROCEDURE FOR SCHOLARSHIP

1. **COMPLETED APPLICATION.** Applicants must complete the attached application form and essay and return it to the Meskwaki Tribal Court by 4:30pm on May 15, 2025.

2. **ESSAY.** As a part of the application, Applicants must complete a 300-500 word typed essay, double-spaced, 12 point font (see application form for topics to address).
3. **SELECTION.** Each completed application shall be reviewed and selection of the scholarship recipient will be made by the Meskwaki Tribal Court Scholarship Committee.
4. **PHOTO (optional):** Please submit a photo of good quality for use in tribal newsletter and other Tribal Court publications. Photo is optional and does not affect scholarship eligibility.
5. **AWARD RESTRICTIONS.** Scholarship must be used towards any two or four year course of study at an approved college, university, trade and technical school. Scholarship must be used during the first post-high school year. The recipient may receive the award only once.

NOTE: Incomplete applications will not be considered.
