Terms and conditions

Please read my terms and conditions carefully. Once you respond in agreement to begin work with me, you are explicitly agreeing to these terms and conditions.

Henceforth "We", "Me" or "I" refers to Shubblie Publications/Services provided by Jasmine Aziz. "You" or "Client" refers to you.

Things to take note out from my side:

- I strive to complete any editing work by the mutually agreed upon deadline we set together. Life happens and there may be times that I won't be able to meet your deadline but know that I will let you know if there will be a delay as soon as possible. I strive to get the work done by the date we agree upon.
- You can expect a professional, courteous and honest response from me in all our dealings and I ask the same of you.
- I will edit according to standard US/American/Canadian English spelling. I am not a machine so there may be things I miss. The bulk of my service comes from suggestions on different approaches, editing sentence structure for optimal flow, and so on. We will discuss this in full when we agree to work together.
- You are the sole owner of your work. I bear no claim to it whatsoever including any and all suggestions I make to you for story enhancements or alternative directions for you to consider.
- I am not a lawyer (never played one on T.V. either) so if there are legality issues with your writing or copyright infringements I may not notice them though I will strive to point them out if I see things that may cause an issue and need further investigation on your part.

What I need from you:

- Please provide a deadline for your edits and anything special to take note of in the formatting as in, intentionally long sentences, phrasing, special nuances that you want to be left alone and so on.
- Please submit your work to me by the deadline we agree upon so I can begin working on it as efficiently as possible.

Payment:

• Work cannot begin until half the agreed upon fee is provided. Full payment is required before I release the finished edits.

- The fee for editing your work is based upon the fees listed on my website. Any additional
 work will be assessed and agreed upon by both parties before we continue our work
 together.
- Quotes are valid for *one week* after they are provided to you by me.
- The price does not include tax at this time.
- If the number of words I edit differs from those stated in your quote, I will adjust my fee accordingly and let you know.

Once the edits are done...

• Once the edits are sent to you, take your time to absorb the notes, make your changes and think about any suggestions that I have made. If you wish to make some changes and resubmit your work for further edits, please contact me and we will negotiate a discounted rate for the second, third, however many edits to come.

Copyright and ownership of content is solely yours.
