INSTALLMENT PAYMENT PLAN AGREEMENT

This Installment Payment Plan Agreement ("Agreement") is made between the County of Lenawee ("County") and the Kiwanis Regional Trail Authority ("KRTA").

I. EFFECTIVE DATE

The effective date of this Agreement is July 28, 2025.

II. OUTSTANDING BALANCE

At the time of the effective date of this Agreement, the KRTA owes the County One Hundred Eight Seven Thousand One Hundred Fifty-Seven and 77/100 (\$187,157.77) relating to an outstanding balance.

III. INTEREST

There shall be no interest associated with the balance noted above. The only obligation of the KRTA is to repay the principal balance on the terms noted below.

IV. REPAYMENT PLAN

KRTA agrees to pay the total amount of the outstanding balance in annual payments of Ten Thousand and 00/100 (\$10,000.00) Dollars per year, with the first payment being made in 2025. In 2035, KRTA shall pay to the County the remaining outstanding balance of Eighty Seven Thousand One Hundred Fifty-Seven and 77/100 (\$87,157.77) Dollars as a balloon payment for that amount that remains outstanding over and above the Ten Thousand and 00/100 (\$10,000.00) Dollars annual payment paid over ten (10) years.

V. LATE PAYMENT

If the KRTA is late by more than thirty (30) days for any annual payment, it shall be considered late. If a payment is late, the KRTA shall be charged a late fee of three (3%) percent of the outstanding annual payment due.

VI. ACCELERATION

The County shall have the right to declare the total amount to be immediately due and payable, if any of the following events are to occur:

- a. Late Payment. If any payment that is due under the payment schedule noted above is late for more than sixty (60) days; or
- Default. If the KRTA should default on any of the conditions of this Agreement.

VII. DISPUTES

In the event any payment under this Agreement is not paid when due, the KRTA agrees to pay, in addition to the principal and interest hereunder, reasonable attorney's fees plus all other reasonable expenses incurred by the County in exercising any of its rights and remedies upon default.

VIII. SEVERABILITY

If any provision of this Agreement or the application thereof shall, for any reason and to any extent, be invalid or unenforceable, neither the remainder of this Agreement nor the application of the provision to other persons, entities or circumstances shall be affected, thereby, but instead shall be enforced to the maximum extent permitted by law.

IX. GOVERNING LAW

This Agreement shall be construed and governed by the laws of the State of Michigan.

X. ENTIRE AGREEMENT

This Agreement contains all of the terms agreed to by the parties relating to its subject matter, including any attachments or addendums. This Agreement replaces all previous discussions, understandings and oral agreements. The County and the KRTA agree to the terms and conditions and shall be bound until the entire outstanding amount due to the County from KRTA of One Hundred Eighty Seven Thousand One Hundred Fifty-Seven and 77/100 (\$187,157.77) Dollars is repaid in full.

IN WITNESS WHEREOF, the COUNTY OF LENAWEEE and the KIWANIS REGIONAL TRAIL AUTHORITY have executed this Agreement on the dates indicated below.
