The Kiwanis Regional Trail Authority met on Tuesday, February 14, 2023 at 9:00 AM in the Adrian City Chambers.

#### 1 CALL TO ORDER

Chair Steele called the meeting to order at 9:00 AM.

#### 2 ROLL CALL / ESTABLISHMENT OF A QUORUM

Present: Chair Steele, Member Elliott, Member Koehn, Member Swallow, Member Hawkins

#### 3 APPROVAL OF AGENDA

#### 4 APPROVAL OF MEETING MINUTES

- **4.1** Approval of the January 10, 2023 meeting minutes
  - Member Hawkins, as was absent from the January 10, 2023 meeting, wanted to
    clarify that the bill for the stump removal should be paid as it was part of the
    easement agreement with the residents along the trail extension, as the minutes
    reflected possible confusion on that topic

#### 6 TREASURERS REPORT - GREG ELLIOTT

- 6.1 Approval of the Treasurer's Report Period Ending January 31, 2023
  - Member Elliott reported no activity for January 2023
  - Also provided a balance sheet giving a fund balance of \$126,723.56
  - Member Swallow clarified that a \$990.00 invoice for the stump removal should be paid
  - Member Hawkins discussed a donor (Tom Dabrowiak) needing a receipt for his 12/20/23 contribution

**Motion by Member Koehn, support by Member Swallow**, to approve the Treasurer's Report Period Ending January 31, 2023

#### 7 NEW BUSINESS:

- 7.1 Maintenance Existing Trail
  - Member Elliott relayed a report from Jason nothing new to report, two litter receptacles were put on the trail extension
  - Member Hawkins ran the trail and noted that the extension, from Tecumseh trailhead to Ives Rd intersection is and back is a 5k
  - Noticed a lot of debris from the hole digging where the fence is going back up
  - Member Swallow mentioned that fence being a part of the road commission contract and could contact them to help clean that up and also will discuss moving Mr. Brown's NO TRESPASSING signs
- 7.2 KRTA Priority Projects
  - a. Tecumseh Connection
    - 1. Construction Update
      - Chair Steele provided a document to the authority "Kiwanis Trail Revenues as of 02/01/2023"
      - Discussion that the construction is about 95% complete, with some curb work and grass restoration still needed but is included in Slusarksi's retainage – so no additional cost
      - The County fronted the outstanding money
      - From a deficit standpoint there were unforeseen expenses, like the 36 trees, coming to \$-53,321.37
      - · Chair Steele does not feel going back to the donor base is right

- Chair Steele identified five \$25,000.00 donors, along with the biggest donors being City of Tecumseh and Kiwanis then lower amounts – Chair Steele and Member Swallow have worked on those identifications and getting a database together with contact info
- Open to discussion on how to close the gap
- Member Koehn clarified that the County was not asked to contribute and that they are owed the deficit amount
- A discussion took place on fundraising and the four cities/townships contributing to the remaining balance
- Member Hawkins is ready to start plans for fundraising with the May 20, 2023 opening to contribute to the deficit
- Member Swallow discussed some of the other bigger costs that impacted the deficit – \$35,000 for additional engineering costs, another \$80,000 for oversight, \$40,000 for tree removal as well as \$17,000 for pipe improvements, although a storm stewer did not have to be installed
- Member Swallow noted the Thompson Fund, an LCF fund dedicated to Tecumseh that reimburse the City of Tecumseh once more funding becomes available, which is why Tecumseh should be able to front \$100,000
- Chair Steel noted that all the funding provided within the organization is for maintenance, but questioned if any of those unforeseen expenses could constitute more funding from within
- A discussion took place on the issues with paying the amount after a fundraiser or fronting the money and getting reimbursed once the fundraiser happens
- There was also note of additional landscaping expenses that will be added to the current deficit
- · Member Hawkins will take the issue to his board
- There should be an answer by next meeting as to how and when the current standing deficit is to be paid

#### 2. Fundraising Update

- Member Hawkins mentioned the road commission possibly giving a small strip of property on the South side of Russell to the City for a trail crossing instead of at the light
- Member Swallow mentioned a Parks and Recreation meeting held the night prior to get the public opinion on applying for a

trust fund grant for a Cal Zorn Park project

- City of Tecumseh Parks and Recreation Director, Sarah Gilmore, explained the grant, through the DNR, will be applied for and currently looking at the best place to cross with Wade Trim. Also, for Trailhead – looking at additional parking, kiosk, donor board, service stations, additional bathroom and water fountain
- Cal Zorn Park is about 15 acres total
- Gilmore will send out the Powerpoint slides for visuals to the board members
- Member Swallow mentioned the Authority considering a letter of support at the next meeting pertaining to that grant
- Chair Steele and Member Swallow clarified the project is looking to be over \$750,000
- Chair Steele will add the Trailhead to the agenda feature
- b. Valley Road to ProMedica Campus
  - On hold
  - 1. Draft Letter to Property Owners

    - Member Hawkins mentioned starting particular event as a 5k but can increase distance for future events
    - Member Hawkins will get on runmichigan.com to get on the calendar once permission is given from the authority and a budget is given and a name for the run

**Motion by Member Elliott, support by Member Koehn**, to authorize up to \$5,000 for a promotional run on May 20, 2023

Motion passed unanimously

- A discussion on names continued, KRTA 5K was suggested and Member Hawkins will continue to think of more creative ideas, but to post on runmichigan.com will use the KRTA 5K
- Member Swallow mentioned the help of Jessica Stretch and combining with the Tri-Athlon as well as Kiwanis Club of Tecumseh
- Member Hawkins will be sure to have flyers for this run available to hand out at the Top of the Mornin' 5K in Tecumseh in March
- Chair Steele recognized we will need to recognize the big and small donors and families and Member Swallow mentioned having something physical to give them that day along with visuals of the completed Trailhead, Member Hawkins mentioned yard signs with donor names along the trail for the run
- A discussion of real permanent signs for the 5 larger donors took place

  - Chair Steele showed a flyer with a QR code that will be placed along the trail that brings you to the website

  - Went through the website, Member Hawkins will post a link on his website, some information will need to be updated with the extension information

- 7.5 Gleaner Arbor Project Clean Up
  - a. Mark Lenz
    - Mark Lenz with Legacy Arbor of Gleaner Life planning a trail clean up as a service project to get their 100 or so members involved
    - Planning on April 22, 2023 which is Earth Day and the 10<sup>th</sup> anniversary of Discover Trails Day
    - Have permission from St. Johns Lutheran to set up there as a base with a food truck, refreshments
    - · Will promote to members and community
    - First time event, no idea of the type of turn out that will happen

- Plan to pick up trash and would like to make sure there are places to deposit that as well as have access to litter sticks and gloves
- Planning on picking up only, has been working with Jeremiah Davies of the City of Adrian
- Member Swallow noted there may not be enough trash for a large number of members and suggested bringing own pruners/loppers
- The Authority agreed to support the clean-up project

- In agreement that if an easement was created, the Authority could maintain it if that's what the residents and HOA agree upon, question if a member was willing to go to one of their HOA meetings

Michigan Natural Resources Trust Fund Board,

Please accept this letter of support for the proposed trailhead development at Cal Zorn Park in Tecumseh, Michigan on behalf of the Kiwanis Regional Trail Authority (KRTA). The KRTA was created in November of 2020. The members include representatives from the City of Adrian, Adrian Charter Township, Raisin Charter Township, and the City of Tecumseh.

Through collaboration and shared resources, our mission is to improve the footprint and the quality of our existing Kiwanis Trail. Spanning 8 miles from the City of Adrian through both Townships, the original trail that was built in the 80s and 90s but stopped 1½ miles short of reaching Tecumseh. After a successful Michigan Natural Resources Trust Fund grant application by Lenawee County, a capital campaign, and crowdfunding effort, the Tecumseh Connection was completed in November of 2022.

We feel this proposal would contribute to a better trail user experience. The proposed bathroom, parking, wayfinding signage, bike service station in addition to the existing picnic facilities at Cal Zorn Park in Tecumseh would make the Kiwanis Trail even more welcoming to users – providing resources to make their time more enjoyable. Successfully extending the trail into Tecumseh provides opportunity for more people to access this recreation resource. These proposed facilities would support 5K run/walk events, half marathons, and volunteer efforts that the KRTA plans to host in the future. Because this trail is the only non-motorized trail in Lenawee County that spans multiple jurisdictions, it demonstrates the cooperation, shared benefit, and investment in our communities.

A trailhead with facilities would be a tremendous asset by elevating the trail experience and overall enjoyment of trail users. It is with great enthusiasm that we, the Kiwanis Regional Trail Authority, support this grant application.
