Are you a Black Mother impacted by the criminal justice system? Have you been ostracized by society for a crime your child committed or accused of committing? Have you lost a child to gun violence? Are you sick and tired of being sick and tired?? If you answered yes to any of these questions, the Black Mothers 4 Justice Magazine is for you!!!

In 2016 my then twenty-year old son was in his junior year of college when he was wrongfully incarcerated for stabbing a student to death during a brawl on the campus of a prominent HBCU in Baltimore, Maryland. He was taken to trial with no DNA evidence linking him to the crime and found NOT GUILTY of the bogus murder charges, however, during the trial the racist judge "added" an accessory after the fact charge that wasn't a part of the indictment, to which he was found guilty. The sentencing investigator recommended time served and probation because my son had NO PRIORS, but the judge gave him TEN YEARS for the non-violent offense. Three and a half years later the Court of Appeals overturned the conviction, and he came home, but his life will never be the same. Sadly, the student's murder remains UNSOLVED today!!!

I had no idea how corrupt the criminal justice system was until it knocked on my door and if it happened to my son it can happen to yours. During those dark days God revealed to me that I wasn't just fighting for My Son, but I was fighting for Our Sons, and I vowed to give Black Mothers something we've never had...a Voice!! Too often we hear about innocent Black Men getting exonerated after spending years in prison for crimes they didn't commit, but you never hear about their Mothers, many of whom died broken hearted long before their sons' convictions were overturned. Although they were silenced, Black Mothers 4 Justice stands on their shoulders and are honored to pay them homage.

The Black Mothers 4 Justice Magazine is a space where Mothers can share their "untold" stories of injustice. It's an opportunity for them to have their voices heard and bring closure to begin the healing process. Our mission is to bring Black Mothers together from city to city and state to state to Rebuild the Village that is desperately needed in the Black Community!!!

### Nadia Fischer Social Justice Activist



Nadia Fischer is a native of Flint, Michigan and a significant aspect of her contribution is advocacy and public relations work on behalf of mothers of murdered sons. She was the catalyst for the relevancy for, Mothers of the Movement- a group formed to campaign with former Secretary of State Hillary Clinton in support of her candidacy for President of the United States and advocate for an end to senseless acts of violence. This group of mothers included: Sybrina Fulton (Trayvon Martin), Geneva Reed-Veal (Sandra Bland), Gwen Carr (Eric Garner), Maria Hamilton (Dontre Hamilton), Congresswoman Lucy McBath (Jordan Davis) and others for social justice reform involving police and African American citizens, especially

black males. Nadia felt these tragedies needed a much larger voice, so she shifted her passion toward television. Her involvement is credited with television networks such as TV One Limited Docuseries and BET. Some of her projects include: Two Sides narrated by Viola Davis, The Quad, Black Girls Rock, and The High Cost of Membership a Columbia University Legal Documentary Studies Initiative.

In 2014, Nadia established "Incarceration Relief Resource Center," a nonprofit organization dedicated to faith and community based interventions for offender re-entry. IRRC is a nationwide social justice advocacy organization with the mission to reduce incarceration and improve outcomes for system-involved offenders. IRRC assists offenders to successfully re-enter their communities by helping to provide

housing employment, education, access to effective mental health, chemical dependency, primary care treatment services, government assistance programs, and spiritual connectedness. To date, Nadia has been the conduit for the release of 102 returning citizens, with 0% recidivism.

As the Chair of Cincinnati NAACP Prison Branch Committee and the Community Lead MOBB United, Nadia is charged with extending community and educational resources to returning citizens as well as emotional encouragement to support broken-hearted hurting, moms of incarcerated sons. The emotional aftermath of incarceration is often overlooked by the judicial system and the public when families lose their loved ones to the system. Nadia's goal is to raise global awareness of the silent cries and deep emotional trauma experienced by the population that she serves.

subjected to by an unfair and unjust criminal justice system.


Joquelle is a long-time member of Union Temple Baptist Church in Washington, D.C. and accredits her faith for sustaining her and her son during those dark days.

#### Grieving D.C. Mother Reflects on Losing Two of Her Kids to Gun Violence the Same Night!

It has been 28 years since Shanda Smith's nineteen-year-old son and fourteen-year-old daughter were gunned down in the streets of Washington, D.C. in a case of mistaken identity on December 17, 1993. Rodney was home from college on Christmas break and Volante' was a fourteen an honor roll student in high school. Shanda and the family were on their way to Marion Barry's annual Christmas party when her Life was changed forever.

She remembers standing in the morgue to identify her babies and promising them that she would see to it that justice would be served. Rodney was driving the car and Volante' was in the passenger seat when their car was sprayed with bullets. Every bullet that entered Rodney's body went straight through and struck Volante's killing them on impact. After leaving the morgue she went back to the scene of the crime, where there was no yellow tape or blood on the ground. She fell to her knees and prayed the Lord's prayer and asked God to use her.

Eight years had passed when she received a call from a homicide detective informing her that they had suspects in custody. The following year they went to trial. Six codefendants and thirty victims. It was one of the first death penalty trials to come back to the Nation's Capital after residents had voted it out. They spent nearly a year of deliberating and the jury found all the defendants guilty and although they were seeking the death penalty it wasn't in me to witness a man die so I was glad he was sentenced to Life in Prison.

Shanda is the Founder and Executive Director of MURDERMISTAKEN, a notforprofit organization created to help families of homicide victims in the Nation's Capital. Shanda has been sponsoring and hosting annual Christmas parties for children who've lost parents to gun violence out of pocket over 15 years to help fill the void of missing their parents during the holidays, which helps her just as much. Her commitment does not go unnoticed and has not been in vain with the support of the D.C. Metropolitan Police Department, the U.S. Attorney's Office and other organizations.

Remembering the many sacrifices JESUS made just for me. Reassuring myself that I'm stronger than I think I am, and that I share the DNA and carry the knowledge, wisdom and experiences of some very RESILIENT women.




