Most of the breeders raise quite a few, but are plagued with long ears and bad coats as the summer progresses. Everyone is trying to save the best ones for the Louisville Convention in October. I guess most of us are limited to the number of vacant cages we have available when we start weaning litters. It's a tough game to play when you have to make your choices at 8 or 9 weeks of age. I believe we probably send a lot of good rabbits to the processor due to lack of cage space. I've pulled one

out of the meat cage more than once due to later development. They didn't look nearly as good the first time through when they were culled for keepers. This goes back to where the bigger breeders have the advantage due to numbers. It's hard to come out on top when you have one good one and your competitor has four or five good ones. I received a note from a concerned member about the use of club funds? They questioned the mailing of the ballots and the cost to both the club and members. They also questioned why I didn't use the .41 *Forever Stamps*, instead of the .42 stamps that I did use?

1. Since this year we had to vote on "Standard" change, by ARBA rule this MUST be done by 1st Class mail. It was decided, since we did have to mail this ballot that we would combine it with our election. Please re-

member this, when we do put a ballot in the Times, the printer charges us extra for that, there is no real savings doing it this way.

2. The .41 *Forever Stamps*, if I would have thought back when the postal increase was mentioned I could have purchased these stamps at that time. I did not, and the mailing cost us an additional total of approximately \$4.00 using the .42 stamps. I honestly believe, Julie & I save the Federation much more than \$4.00 per year and we will continue to do all we can for the Federation.

This member asked for a Total Disclosure of this Misuse of Club Funds. This is the best I can do to explain this.

If there is any other questions about this, please let me know. If you can help with any of the above items, please do so. All help is greatly appreciated. We look forward to seeing you all in KY.

In closing let me mention the 2009 National in Illinois. I would expect to see more information after the Convention. Please watch both the website & Times for details. This should be another Great National. The Californian National is being held in conjunction with ours. What a wonderful showcase of these two terrific breeds.

Directors Reports

We hope that all our fellow New Zealand breeders are doing well and that their rabbits are making it OK through the hot summer weather. It has been both hot and cold here in northern California. The weather has finally moderated. This makes us all happy, especially the rabbits.

It has been unbelievably dry in California. This has contributed to the largest fire season in recorded history. Over one million acres have burned so far. At one time there were over 20,000 firefighters- fighting over 300 fires at the same time. Many of them came from surrounding states as well as Canada, Mexico, Australia and New Zealand. The scary part is that the fire season started very early this year.

I had the privilege of judging the Washington State Convention at the end of June in Ellensburg. It is probably the best show in the western United States and is held over a two- day period. All 10 of the judges were from out of state. It was good to visit with and get to know many of these judges better. You normally only get to say "hi" in passing at conventions.

There was a good entry of all three New Zealand colors. On Saturday Jean Harris won BOB and Denise and Windy Konzek BOS with whites. Jean Harris won BOV black and Judie Currie won BOV red. On Sunday Jean Harris won BOB with a black doe and Judie Currie BOS with a white buck. Denise Konzek won a competitive meat pen class with a very strong black pen. The northwest women New Zealand breeders are to be commended for winning all the top awards. It is unfortunate that Dale Wilcox and Wally Sticklemeyer (both old time- top line New Zealand breeders) were unable to show because of their health.

This year, for the first time in many years, we decided to show our rabbits at the Sonoma County Fair in Santa Rosa, which is one of the major fairs in California. There were about 15 reds entered. Linda entered 6 and won all six classes. We had the good fortune to win BIS with an intermediate white doe.

There was a very strong demand, this year, for New Zealand meat pens for the summer fairs. We could have sold an untold number

of pens but just didn't have them. There were 25 meat pens at the Sonoma County Fair (2 NZW pens and 23 Cal pens). The New Zealands placed second and third. Close but not close enough. Later that same week, I was informed that a New Zealand White pen won the grand champion pen award at the Santa Barbara County Fair- a fair that had long been dominated by Cal pens.

We are just beginning to look over and organize our potential convention rabbits, as are many of you. Like every year, it will be a race to see if one can get them in prime coat by convention time!

We've just concluded making our arrangements for the convention and are shocked at the increased cost of everything. It is not just gas and airfare. It used to cost \$75 to ship a kennel on Delta. Now it costs \$200 each way- that's \$400 round trip for each kennel! They have also recently instituted a \$50 charge for checking a second bag.

With the price of everything going up the way it has been, it makes one question how much longer one can afford to go both to the convention and the national show in the same year.

In any case, we are going to Louisville and hope to see many of you there. Good luck and good health.

New Zealand Blues Update—Sue Schmidt

I thought I would write a short article about the Blue New Zealands. I first presented the Blues in Portland, OR, they did not pass. I then presented them again in Louisville, KY. Again they did not pass. Needless to say I was very disappointed, but determined to try again, so here I am doing it again.

In retrospect I have to say that the color has greatly improved from those first animals that I presented. I very seldom get anything but blues when I breed blue to blue. The depth of color is much better. I have found that if I cross a black into the blue I lose the good depth of color on the first cross. I would like to see a little better body, but

I seem to extra critical of my own rabbits. I am getting a little nervous as 2 of the litters that I had hoped to use for presentation animals have lost several of the litter one is down to 3 and the other is 5 I think Arnie said. I just hope that I will have enough to make my presentation.

I thought I would give you a little history on how I got the blue color. My first pair of does came from Pleaz Kirby, they were a very mealy blue color, they were out of a red and white cross doe bred back to a black buck (w/cal in background). My next dilemma was to find a blue buck to breed them to. That was solved when Gary Mohr left a blue satin buck behind at the Illinois State Convention. He had left, so we brought it home, I called him to see if I could use him. That is what got me my first litters. I then got a buck and a doe from Charlie Crabtree and that was the real beginning of good color and type. Also got a couple of animals from the Klindts.

More recently we got some animals from Al Esterline and David Mills. My gene pool was getting way to small.

I hope that helps to raise interest in the blues, anyone interested please call or e-mail me. I would have pictures however you can't appreciate the blue color in black & white. Hope to have some posted to the website soon.
