I should be fun.

seem to have given us a break!! We brought several bred Does and Herd Bucks into the basement to keep them cool. The fans have been running non-stop. We have had several days with a heat index of 115 degrees!

Cold water was a must twice a day. I had to drain the automatic waterers sometimes twice a day to be able to have fresh cold water for the rabbits. For me plastic water bottles proved to be the worst at the end of the day. The water was warm...I also found it critical to watch the food intake of each individual rabbit. Always finding myself adjusting each rabbits food intake depending upon the weather. High humidity always presents a challenge with the food as I find myself dumping food....economical it is not, but only the best for the rabbits health.(it get soft and spoils). We have gone to feeding a small amount in the morning and then again in the evening. The fresh food certainly has not allowed them to be stressed. With all of this said we hope that everybody has some good rabbits for Indy. This show should prove to be a "GOOD" show according to Al Esterline. He is diligently working on this show. A thank you sent to Paul Grunditch for your kind donation for the rabbits for the raffle.

New Zealand Information ~ FINAL UPDATE

I am getting excited about the convention; it could be the greatest ever. It has been very hot this summer, but the other day I heard that Texas has had 31 straight days of over 100 degree temperatures, so I don't feel quite so bad. I have been working on this convention project since one year ago January. We are now only a couple of months away from the convention. The Marten House Hotel has worked with us to put together the best economic and the best facilities without having to leave the building...

Updating information about our official AFNZRBA hotel headquarters The Marten House and Lilly Conference Center. The Marten House is owned by and is affiliated with St. Vincent Hospital and is on the same campus. It is in a prestigious Northeast side of Indianapolis, on 86th street with shopping and restaurants. The Marten House is exactly 9.3 miles from the Indianapolis State Fairgrounds. Maps will be available at the New Zealand booth. The New Zealand club block of rooms has been filled, but the Hotel will still offer the \$60.00 plus tax, per night, till September 29, 2011. Provided, space is available. As of July 1st. we have 73 rooms reserved, that is great. The Marten House is a non-smoking facility, since it is owned by the hospital but you can smoke outside

There is a coin operated laundry room for the hotel occupants. The indoor pool is very nice and it also has tables that you can sit at and visit. The pool hours are 6-11 pm.

We have a hospitality room reserved, that will be available for the NZ people getting together and visit. Saturday night will be a special get acquainted night in the hospitality room. Monday the 31st there will be a Halloween party night, come dressed. As of now the room number is 1117. The hospitality room will be open every night. If you have a special beverage bring with.

(VERY IMPORTANT)

On Sunday October 30th our show day, the restaurant has 99% agreed to open at 5:00 am for the rabbit people so that we can get to the show room, which opens at 6:00 am.

The restaurant in the hotel has changed; it is now called 18-81 Grill.
