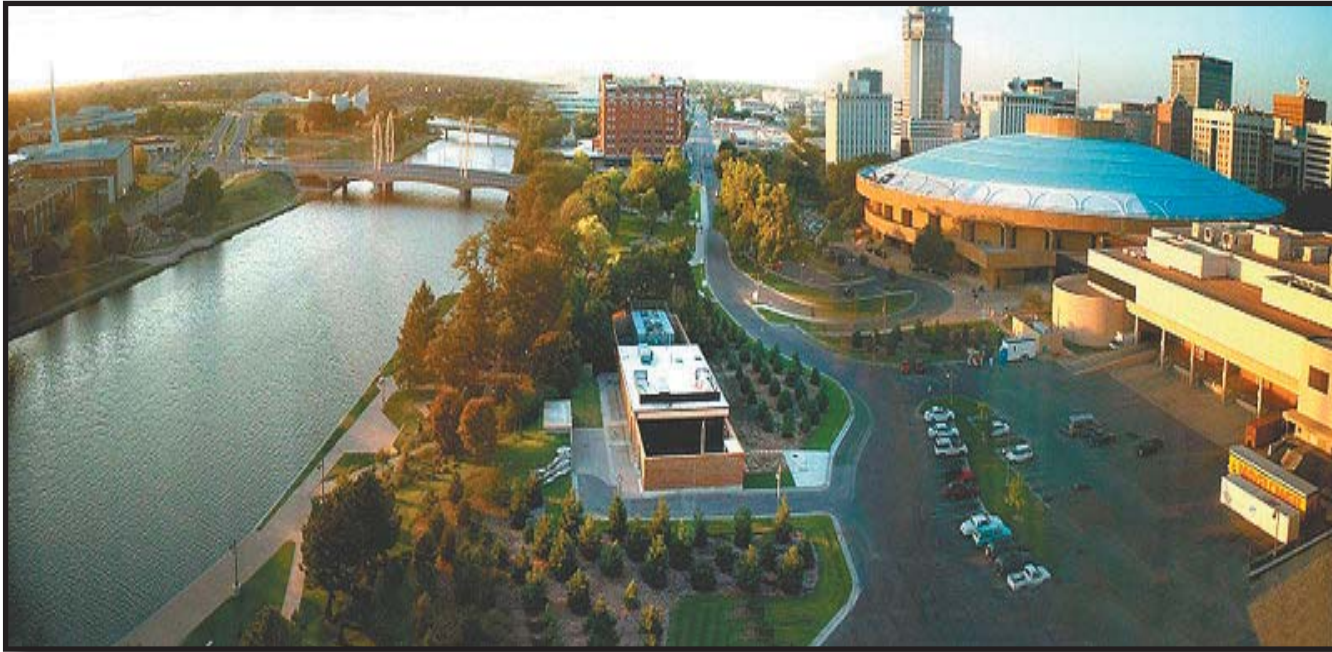

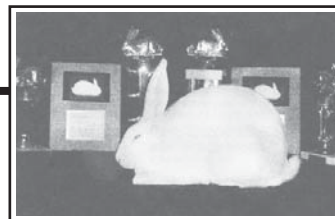

Vice-President's Report

*H*ello to all,

I know everyone is tired about hearing of the heat. It has been brutal here in the east. High temp and humidity, but we have been able to maintain an average temp of 75 degrees in the rabbitry. Tony Folker and myself have changed our fan system to all ceiling fans. After a trip to Farmer Boy Ag, they do Ag buildings. With their advice we went to 56" ceiling fans with downdraft. These are industrial fans costing around \$90.00.

One fan easily takes care of 300 sq Feet, I have mine hooked up to a thermostat and Tony has his hooked up to variable speed control where he can control the speed.

What makes the ceiling fan much better is the air flow is down into all the pens, where as the other fans blow it in front and above and the solid partitions blocks the air flow.

The rabbits seem much more comfortable and also seem to eat better in the high heat.

Another thing for outside rabbits with little shade is greenhouse netting. It is a black mesh netting which shades out direct sunlight. It is inexpensive and can be purchased at a greenhouse supply house. Also, beware in extreme heat automatic watering systems get very warm and should be drained frequently to insure fresh cold water.

Good luck to everyone and keep your bunnies cool.

I feel this is a good move for them, then they know exactly what to expect when rabbits are booked on a flight.

I hope all are surviving this crazy weather. From day to day we never really know what to expect. Hope to see many of you in Wichita.

Proposed change to the AFNZRB Constitution and By-Laws

I, Anthony Bell, as a member in good standing of the American Federation of New Zealand Rabbit Breeders, propose the following changes and addition to the Constitution and By-Laws of said organization;

* Article V, Sections 1, 3 and 4 of the Constitution currently read:

Section 1. The officers of this Federation shall consist of a President, Vice President, a Secretary – Treasurer, and twelve Directors. Not more than two directors or four members of the Board of Directors shall be from the same state. These fifteen and the immediate Past President for one year following his term, as long as he holds no other office in the Federation, shall constitute the Board of Directors.

Section 3. The President, Vice President and six Directors shall be elected every odd numbered year, for a two-year term. The Secretary – Treasurer and the other six Directors shall be elected every even numbered year for a two-year term. The number of consecutive terms in one office shall be two (2) for the President and Vice President, five (5) for a Director and indefinite for the Secretary – Treasurer.

Section 4. Vacancies in office shall be filled by appointment by the President.

* They should be changed to read:

Section 1. The officers of this Federation shall consist of a President, Vice President, a Secretary – Treasurer, and eight Directors. Not more than two directors and a total of four members of the Board of Directors shall be from the same state. These eleven shall constitute the Board of Directors.

Section 3. The President and four Directors shall be elected every odd numbered year, for a two-year term. The Secretary – Treasurer, Vice President and the other four Directors shall be elected every even numbered year for a two-year term. The number of consecutive terms in one office shall be two (2) for the President and Vice President, five (5) for a Director and indefinite for the Secretary – Treasurer.

Section 4. Vacancies in office shall be filled by appointment by the President, subject to the approval of the Board of Directors.

* Add the following to Article V of the Constitution as the new Section 3:

Section 3. The immediate past President shall be an ex-officio member of the Board of Directors, acting in the capacity of Advisor until such time as that person is replaced or obtains another office.

* The present Sections 3 and 4 would be re-numbered to Sections 4 and 5, respectively.

* Add the following to Article II of the By-Laws:

Section 6. Any Officer or Director who fails to fulfill the duties and obligations of their office, with no just cause, shall be asked to resign voluntarily by the President or Board of Directors, after receiving the approval for such an action from the Ethics Committee. If the voluntary resignation is not submitted, the office in question can be opened by a two-thirds (2/3) majority vote of the Board of Directors.

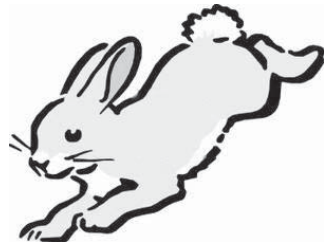

Jump Start



This article is not to be taken as a commercial. I am writing this article, because of the amount of questions that has arisen from emails, phone calls and discussions about the use of Nutri-Drops. Why do Rabbits go off feed? That has been a lifelong mystery for me, there are many theories out there but none have satisfied me. The use of Nutri-Drops does not cure bacterial or viral infections but it helps keep their resistance up. Nutri-Drops are very high in nutritional products and vitamins. This product is made by Bovidr Laboratories, Inc. and is sold by most rabbit equipment dealers. My introduction to Nutri-Drops was from one of my close friends. What I am about to give you are my personal experiences and opinions.

My first experience was with a doe that went off feed. She had been off feed long enough that Linda and I had no hope for her survival. We decided to try the Nutri-Drops, giving her 3 pumps from an 8 ounce bottle, 3 to 4 times a day. All of a sudden she began eating and came back to full flesh and went on to raise more litters. Another time I had an intermediate buck that was 1 ½ months from a show that had eaten only one teaspoon of pellets in 7 days. I treated the buck the same as the doe previously mentioned. As for the buck, after a week he began eating and held his condition good enough to be shown.

In another example, I had a doe that died when her litter of eight was 3 weeks old. Along with oatmeal and pellets we also administered Nutri-Drops with an oral syringe directly into each baby's mouth every day, until they were big enough to drink from a small water crock, and then the Nutri-Drops was put in with their water supply. The amount of squirts from the Nutri-Drops bottle varied from time to time. I successfully raised all eight.

Last winter it got cold enough for their water crocks to freeze, I watered 2-3 times a day. Two days in a row I would squirt 1 shot from an 8oz bottle on the top of the ice in their crocks, before I had time to add warm water in the crocks, fifty per cent had already licked up the Nutri-Drops before I had a chance to water them.

My favorite way of administering Nutri-Drops for my show rabbits is on dried bread. I get loaves of

(out dated) animal bread, cut the bread slices in half and dry them. Then I apply 1 or 2 squirts of Nutri-Drops on each dried piece of bread. I start about 2 weeks before the show giving each rabbit a piece with a shot of Nutri- Drops on it. Another way I used the bread pieces with Nutri-Drops on it was for treats, especially for my bucks. When they realize treats are coming they get very excited.

I have had rabbits go off feed at a show. The rabbit would be immediately treated with Nutri-Drops directly into the mouth. By the end of the convention they would be eating. I have never overdosed a rabbit or caused any side effects from heavy use of Nutri-Drops.

If any of my experiences in this article helps in your endeavor to raise better rabbits, then it has been my pleasure to share them with you.
