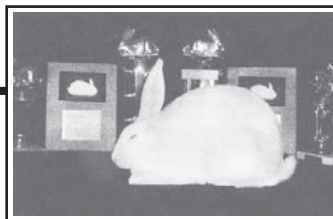

Questions and concerns came up on how to get more breeders to come to the National Shows, as it takes lots of money and lots of hard work and clubs get disappointed when they put in all their time and the results is a small entry. It really is a disappointment and costly. We can't take away sanctions for others to suffer. With the high cost of fuel, members need to change the way they travel, like car pooling and share expenses.

One of the ways to keep entry numbers is by centralizing the show, but then the same breeders will have to travel every year, and is that fair to them? One way to help this New Zealand Rabbit club is get more members to sign up as new breeders, and this will help a lot, as we can use more members because we are declining in numbers. We need to expand our breed to more youth breeders or we will never get any larger, but smaller. We will find ourselves as a minority breed such as others that only have a few shown at convention or National shows. I know that the four class rabbits are growing, but we can't let them walk on us, we have to maintain our breed. To maintain our breed we need to work together and make our membership grow. We need to support and attend our ARBA Conventions and National New Zealand shows and our local shows, and help get the youth involved. Yes you can make a difference, just try and take a extra step forward.

I mentioned at the meeting a change in the standard committee. I want to keep the number of members on the committee. I don't want to add any extra committee members every time we get a new variety excepted. I just want to remove the list of varieties, as the committee members must have knowledge of each variety as a whole.

We had a small problem occur about points at the national shows, We are working on a better wording, but nothing is changing. The points will still count as

they have for years, we are just having it rewritten for a better understanding.

You should have received your ballot for the new variety the Blue New Zealand, being submitted by Al Esterline. YOUR OPINION MATTERS, so please vote. Is it time for a new variety or for that matter a Blue? This is your chance to speak, so vote yes or no. Don't complain if you don't vote,

2012 - Board Meeting NZ National

Fort Worth, TX 4/21/12

The meeting was called to order @ 7:20 am by Pres. Cardinal

Roll Call of Officers, Present: President David Cardinal, Sec-Treas. John Neff

Directors, David Klindt, Mark Manglberger, Arnold Schmidt, Al Esterline, Jean Harris, Wendall Tisher & Lisa Jennings.

President Cardinal asked for the reading of the minutes from the previous BOD meeting. A motion to accept the minutes are printed in the Times was made by Arnold Schmidt, 2nd by Wendall Tisher - Motion passed.

Report of Officers: Sec. Neff read a report sent in by Director Shipe, no other reports were received. Treasurer Neff reported the Federation has \$4,735.47 in Savings (Scholarship) and \$10,022.99 in the General Fund. Motion to accept the Financial Report was made by Jean Harris, 2nd by Arnold Schmidt - Motion passed.

Committee Reports: Awards Committee Chairman Arnold Schmidt reported that he received two names for the Hall of Fame, Terry Grubb & Charlie Crabtree. After a brief discussion a motion was made by Wendall Tisher, 2nd by Mark Manglberger to accept these two names - Motion passed. No names were received for Outstanding Member.

New Business:

ARBA - Blues Presentation: Al Esterline reported on his progress with the Blues. Al has spoken with Cheryl Eng-Link and reported that a ballot must be sent to the General Membership to proceed with this presentation. Sec. Neff will prepare a ballot and get them mailed so that they can be returned to the Election Chairman within the time frame required by the ARBA. The Federation BOD had already voted to proceed with the Blues.

Reducing the Number of Federation Directors: It is felt with our current membership & lack of elections due to the number of members running it is time to reduce the number of Directors. C&BL Chairman, Tony Bell was aware that we were going to discuss this and gave us a proposal to complete this task. After some discussion a motion to reduce the number of Directors to 8 was made by Wendall Tisher, 2nd by Jean Harris - Motion passed. Tony Bell will be asked to get this proposal ready for the presentation to the General Membership.

Standards Committee: Committee Chairman David Cardinal reported that he would like to restructure

the Standards Committee. A motion to accept his proposal was made by Lisa Jennings, 2nd by Arnold Schmidt - Motion passed. David Cardinal will get with C&BL Chairman Tony Bell with his proposed changes.

Sanctions - Same day as National: Under our "Rules for National New Zealand Shows" Rule #8, The Federation shall not issue a show sanction to another club for the same dates as the National New Zealand Show, unless the location of the show is more than 300 miles from the site of the National New Zealand Show. After much discussion a motion was made by Wendall Tisher, 2nd by Lisa Jennings to leave the rule as written - Motion passed.

Best Display Points: After the 2011 ARBA Convention there was a question raised on how Display Points were calculated? Under our "Sweepstakes Show Rules" Rule #10 explains our points system. Display Points are not covered. Since the "Bonus" points were added for BOB/BOS & BOV/BOSV the points earned for these wins were added to the variety points. Therefore for example if a Broken wins BV & goes onto win BOS those "Bonus" points will go towards the Broken Variety Display Points. Regardless how a local club, local or state specialty club calculate points, this is how the Federation will calculate Variety Best Display points. After some discussion, everyone agreed on how this was being done. Motion by Lisa Jennings, 2nd by Jean Harris - Motion passed to continue calculating Display points in this matter. Tony Bell will be contacted to add and clarify the Display points to Rule #10.

Bid 2014 NZ National: John Neff presented a bid from the SENZRBA in conjunction with the KY State RBA to hold the 2014 NZ National in Louisville KY, April 26-27th. A motion was made by Lisa Jennings, 2nd by Jean Harris to accept the bid, Motion - passed...

A motion was made by Lisa Jennings @ 8:25 to adjourn.

Blue New Zealand Variety Color Standard

BLUE: Fur color is to be a dark blue color extending down the guard hair shaft, blending into a slate blue undercoat. The uniform blue color should extend over the body, feet, head, ears, belly and tail. Eye color is to be blue-gray. Toenail color is to be dark.

FAULTS: Stray white hairs, frosting, brown cast, ticking, silvering, an uneven fur coat color.

DISQUALIFICATIONS FROM COMPETITION: Ring color, white belly color, patch or patches of excessive white hairs, large amounts of conspicuous white hairs, excessive brownish cast (not to be confused with an older fur coat), white shadow bars on front or hind feet, one or more white toenails. Eye color other than called for.

EACH VOTING MEMBER WILL RECEIVE A BALLOT TO VOTE ON WHETHER TO ACCEPT OR REJECT THE BLUE NEW ZEALAND PROVIDED IT PASSES THE REQUIRED SHOWINGS AT ARBA CONVENTIONS.

PLEASE DO YOUR PART AS A MEMBER OF THE AFNZRB AND VOTE TO APPROVE OR REJECT THE BLUE VARIETY.

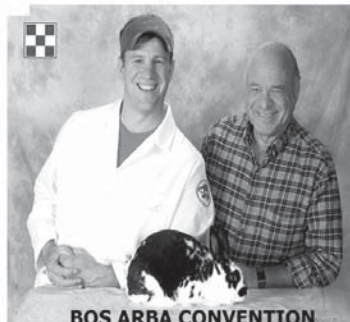

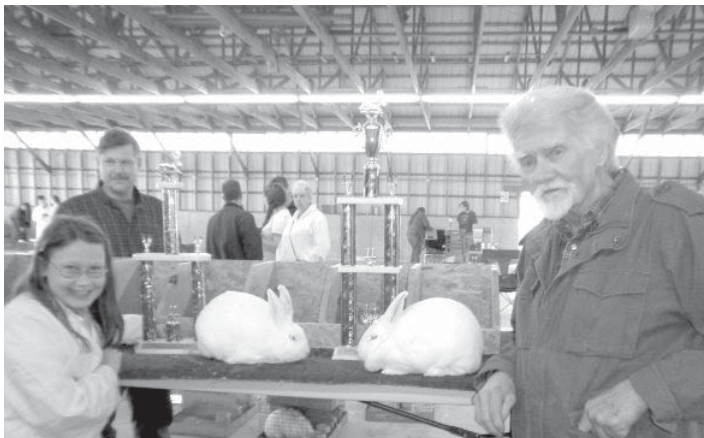

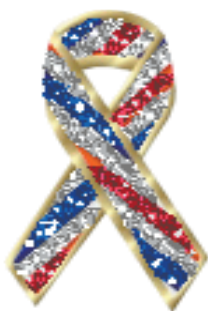
