In consideration of being allowed to participate in equestrian activities at Outlaw Arena and on the premises of the same, by initialing and signing, the undersigned acknowledges, appreciates and agrees:

____ 1. There are inherent risks of injury associated with all equine-related activities, both mounted and non-mounted such as described below, and participant hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of equines to behave in such ways as: running, bucking, biting, kicking, shying, stumbling, rearing, falling, or stepping on, that may result in injury, harm or death to persons on or around them; the unpredictability of equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and substance conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant's ability. Participants acknowledge that horses, by their very nature, are unpredictable and subject to animal whim. Participant assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising as a result. ***I knowingly and freely assume all risks, both known and unknown, even arising from the negligence of others, and assume full responsibility for my use of the premises and participation in activities.***

____ 2. ***Participants warrant all horse(s) shall be free from infection, contagious or transmittable diseases.*** The Outlaw Arena reserves the right to refuse access or use of any horse upon the premises that does not appear to The Outlaw Arena to be in good health, or is deemed dangerous or undesirable.

____ 3. Participant agrees to abide by and follow The Outlaw Arena rules and regulations, which shall be posted and/or available on website. Rules can be added and will be posted prior to events scheduled as necessary.

____ 4. Participant or Participant's Parent or Guardian releases and discharges the Outlaw Arena, it's staff, volunteers and horse owners from any and all responsibility or liability to me, my child, or my family in connection with any injuries or disease suffered by me, my child, or my family as a result of my activity, participation and attendance involving the Outlaw Arena horses/ponies/live stock, property or events. These provisions shall be fully binding upon and shall be effective against the undersigned, its heirs, successors, legal representative, or assigns and shall apply to the actions of the undersigned personally, family, guests, employees, or agents. ***I, for myself and on behalf of my/our heirs, assigns, personal representatives, and next of kin, hereby release the Outlaw Arena, their officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors of premises used to conduct any event, or simple use of the areas, with respect to any and all injury, disability, death, or loss or damage to person or property incident to my involvement in use of the Outlaw Arena premises and/or programs, to the fullest extent of the law.***

____ 5. ***All riders under the age of 18 are required to wear a horseback riding helmet whenever on any horse.***

____ 6. In participating, I am permitting the Outlaw Arena to use the rider's picture, name, or voice on any media for the purpose of advertising or sponsorship.
