COMPREHENSIVE VETERINARY SERVICE, SURGERY & PET TRANSPORT AGREEMENT AND LIABILITY WAIVER

(Unified Legal Document for Clinical, Home Service, Mass Event, and Transport Operations)

This Agreement is entered into by and between:

Pet Owner/Client ("Client") _____ and **Pet Transport by Doc Gab ("Company")**

By signing this document, the Client agrees to the following terms:

I. GENERAL CONSENT & ACKNOWLEDGMENT OF RISKS

The Client confirms that:

- They are the **legal owner/authorized guardian** of the pet
- They voluntarily consent to **veterinary procedures, including surgery (e.g., spay/neuter/kapon), and/or pet transport services**
- They fully understand that **all veterinary procedures and transport activities carry inherent risks**, including but not limited to:
 - Adverse reactions to anesthesia
 - Undetected medical conditions
 - Bleeding, infection, or complications
 - Stress-related illness or deterioration
 - Injury, escape, or death

The Client agrees **not to hold the Company liable** except in cases of **proven gross negligence or willful misconduct**

II. NON-CLINIC / MASS EVENT / HOME SERVICE LIMITATIONS

The Client acknowledges that services may be conducted in:

- Community events
- Mobile/home service settings
- Temporary surgical environments

Thus:

- Equipment and monitoring may be **limited compared to a full veterinary clinic**
- Patient volume may be **higher during mass events**
- Recording, diagnostics, and continuous monitoring may be **restricted**

The Client accepts these limitations and associated risks.

III. ABSENCE OF BLOOD TEST, VACCINATION & FULL HEALTH SCREENING

The Client understands and agrees that:

- Surgery and/or transport **may proceed without blood tests, complete vaccination, or full diagnostic screening if the owner declines to do so**
- Blood tests, even if performed, **do not guarantee detection of all conditions**

The Client accepts full responsibility for:

- Any complications arising from **undetected or underlying diseases**
- Any post-operative or transport-related complications due to incomplete vaccination or screening

All related medical expenses shall be **borne solely by the Client**

IV. ANESTHESIA & SURGICAL CONSENT

The Client acknowledges that:

- Anesthesia carries **inherent risks, including death in rare cases**
- Even with proper protocols, **individual responses may vary**

Risk Disclosure (Transparency Statement):

Based on internal data, approximately **0.03% mortality risk** has been observed (31 cases out of ~102,000 patients), representing a **99.97% safety margin**.

However, this does **not eliminate risk for any individual patient**.

The Client accepts these risks fully.

V. POST-OPERATIVE CARE & DISCHARGE CONDITIONS

The Client acknowledges that:

- Recovery time may vary (**1–12 hours or more**)
- Discharge is based on **clinical assessment at the time**, including:
 - Breathing
 - Reflexes
 - Movement

However:

- Conditions may **change after discharge**, especially during transport
- The Company **does not guarantee continuous recovery progression after release**

The Client agrees to:

- Monitor the pet closely
- Follow all post-operative instructions
- Seek immediate veterinary care when needed

VI. PET TRANSPORT CONDITIONS

A. NO VETERINARIAN ON BOARD

- **No veterinarian will be physically present during transport** unless requested and paid with corresponding fees
- Staff are **non-veterinary transport personnel**
- No medical procedures will be performed during transit

B. TRANSPORT RISKS

The Client accepts risks including:

- Stress-induced complications
- Sudden deterioration
- Environmental changes affecting recovery
- Delays due to traffic or external conditions

C. DEAD ON ARRIVAL / EMERGENCY DURING TRANSIT CLAUSE

The Client acknowledges that:

- A pet may deteriorate rapidly despite prior stability
- In case of emergency:
 - The Company will attempt **reasonable response within capability**
 - The pet may be brought to the nearest veterinary facility if feasible

However:

- The Company **does not guarantee survival during transport**
- The Company is **not liable for death during transit** unless gross negligence is proven

D. THIRD-PARTY / SECONDARY TRANSPORT DISCLAIMER

Once the pet is:

- Released
- Transferred
- Endorsed

to any:

- Third-party transport provider
- Airline / cargo
- External handler

The Company's responsibility is **immediately terminated**

The Company is **not liable** for any incident beyond this point.

VII. ESCAPE, HANDLING & ENVIRONMENTAL RISKS

The Client acknowledges that:

- Animals may escape due to stress or behavior
- Open or unfamiliar environments increase risk

The Client is responsible for:

- Proper cages, carriers, and restraints

The Company is not liable for escape **unless gross negligence is proven**

VIII. FORCE MAJEURE

The Company is not liable for delays, injury, or loss due to:

- Traffic, accidents
- Natural disasters and weather conditions
- Government restrictions
- Mechanical failures

All additional costs (quarantine, delays, rejection) are borne by the Client.
