From the President

Music Teachers Helper

Every new beginning is a chance to do things better than we had before. As small business owners, bookkeeping is an integral part of what we do. If you are anything like me, I would much prefer teaching over handling my finances and preparing tax forms.

After having spent many frustrating hours and days re-creating lesson schedules and payments for families who wanted clarification over their financial status, I knew I needed help. At that time I began my subscription to Music Teachers Helper and found it paid for itself easily in the time it saved me. I also purchased Moosic Studio in an early release, hoping it could replace Music Teachers Helper, but have not found it to be as workable for me.

Music Teachers Helper keeps all my logistical information in one place. My calendar, billing, scheduling, practice minutes logged, repertoire learned, and loaned books information are all available to me. A down side to this program is that it is only available while you are on-line. For those with smart phones, this is a non-issue. For me, it means I actually do get away from my work once in a while.

Every summer, I dreaded the logistics of scheduling lessons. Last year, I experimented with a Google.docs calendar, but found many families uncomfortable with setting up a gmail account just to use it. This summer, I used Music Teachers Helper to offer times I was willing to teach and families were able to sign up for their own slots, the weeks they were available. This worked very well for me. They would also be able to cancel a lesson (with a pop-up reminder of my August-September 2014

cancellation policy) and reschedule the lesson themselves. I would be sent a text message whenever a lesson was cancelled. This has been the easiest summer system I have ever used. The billing is generated off of the same calendar, so much of the work is eliminated.

Last summer, I also sponsored a practice contest using Music Teachers Helper. Each student has their own log in page where they can see their next scheduled lessons, notes from me, and log their practice minutes every day. It was simple for me to check the winners every week and send a quick email to everyone announcing the leaders.

Minnesota Music Teacher Honored As MTNA 50-Year Member

CINCINNATI (August 2, 2014)—Music Teachers National Association (MTNA) recently honored Darlene Wolleat, as a 50-Year Member at the 2014 MTNA National Conference in Chicago, Illinois, March 22– 26.

Wolleat, a nationally certified teacher of music (NCTM), has taught piano for more than 52 years. She received a bachelor's degree in applied piano from Whitworth University. She has been an active member of MTNA, the Minnesota Music Teachers Association (MMTA) and the St. Paul Piano Teachers Association (SPPTA) since her college years. Wolleat still teaches piano to approximately 30 students a week in her studio and has been a church musician since she was a teenager. She has been an accompanist in churches, public schools and colleges, and has also participated in collaborative performances with students and professional musicians.

MTNA is a nonprofit organization comprising of nearly 22,000 independent and collegiate music teachers committed to advancing the value of music study and music-making to society and to supporting the professionalism of music teachers. Founded in 1876, MTNA is the oldest professional music teacher association in the United States.

SPPTA Motions Passed in 2013-2014

- 1. October: The Honors and Awards program and the Recitals program will both be modified and combined so that exceptional performances in Recitals will be invited to play in a special Honors Recital rather than competing for the Honors and Awards Recital.
- 2. October: Dr. Jess Johnson was to be compensated with a \$300 stipend rather than \$200. for the master class in March, 2014.
- 3. March: We accepted the ballot of incoming officers.
- 4. May: We will raise the fees paid to Contest Workshop Presenters: Sr. B. presenter will receive \$400 rather than \$300. Sr. A \$350 rather than \$275. Other levels \$250 rather than \$200.
- 5. May: Recital programmers will be compensated for their work in that the host of any recital may enter up to 4 students in that particular recital without registration fee.

Concerto Competition

So...What are you doing in February?

As the school year starts and our students are selecting backpacks and other supplies, those looking to participate in SPPTA's Concerto Competition are also selecting their piece. To prepare a song to this level of excellence, play it for judges, receive quality feedback, possibly win one of the cash prizes, and be in the running to play your piece in concert with the Mississippi Valley Orchestra...It's amazing! But what about the students who will not be competing? It can be amazing for them as well. Please don't dismiss this event or deem it somehow inapplicable; that would not be accurate.

As you are making your studio schedule for the year, do your students the favor of including 7:30pm, Saturday, November 15^{th,} at Schmitt Music in Roseville, and 4pm, Sunday, February 22^{nd,} at First Lutheran Church in Columbia Heights on your list of upcoming events. By showing both the Finalists' Concert (where the winner is determined), as well as the winner's performance date with the orchestra, there are two chances for students to watch a fellow-musician nearer their own age create something incredible!

This proximity in age automatically makes the performance more relevant. Observation skills go on fullalert and attention spans are stretched, noticing details that could otherwise have gone by un-remarked. Not only can attending have the benefit of challenging and inspiring the listener to increased efforts personally at the piano, it empowers the attendee to play an active role in supporting and affirming another musician in his/her growth. Both of these benefits have ongoing value. Compared to the busyness of springtime schedules, when last year's concert was in May, far less will be competing for calendar time mid-winter, so I ask you, "What are you doing in February?" My students and I invite your students and you, to come and be smiling, clapping, and encouraging audience-members at the Concerto Competition events this year! See you then!
