- Design Solicitation was closed on 08/12/2021. Design Solicitation ranking, with RG Architects ranked as number one, was approved by the Board on 10/26/2021. RG Architects contract was awarded on 03/08/2022.
- CMAR Solicitation was closed on 09/09/2021. CMAR Solicitation ranking, with DeAngelis
 Diamond ranked as number one, was approved by the Board on 11/09/21. Negotiation with
 DeAngelis Diamond is concluded, but Procurement is still waiting on DeAngelis to execute the
 CMAR contract. Contract with DeAngelis will need Board approval.
- David Lawrence Center signed on 03/22/2022 "First Amend Vacant land Contract", and "Termination and Release of Collier County Standard Form Long-Term Lease and Operating Agreement". These documents were presented to the Board for approval on 04/12/22.
- Design Kick-Off Meeting: 03/23/2022. Biweekly meetings with all stakeholders and the Design Team are ongoing.
- Programming Phase ended on 05/31/2022.
- Schematic Design Phase started on 06/22/2022 and ended on 08/03/2022. We are currently reviewing the Schematic Design Documents.
- Rezoning Process: first public meeting was held at the Golden Gate Community Auditorium on 05/04/22. Neighbors Information Meeting – mandatory – was held at the Golden Gate Community Auditorium on 07/26/22.
