IN CONSIDERATION of signing myself and/or my child (“**Participant**”) up for Swim Lessons (“**Lessons**”):

On behalf of Participant:

1. I Acknowledge, Agree, and Represent that I understand the nature of swim lessons and that Participant is qualified, in good health, and in proper physical condition to participate in the Lessons. I further Agree and Warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Lessons.
2. I fully understand that during the swim lessons, **NO LIFEGUARD WILL BE ON DECK.**
3. I Fully understand that: (a) **swim lessons involve risks and dangers of serious bodily injury, including permanent disability, paralysis, and death both foreseeable and unforeseeable (“Risks”)**; (b) these Risks and dangers may be caused by Participant’s own actions or inaction’s, the condition in which the activities take place, or the **negligence of the Releasees as defined below**;
4. I fully accept and assume all such risks and all responsibility for losses, costs and damages I incur resulting from participation by the Participant in the activities.
5. **Covid-19 Acknowledgement.** I fully understand that the Coronavirus (a/k/a Covid-19) is a risk with any activities that are not solitary. I acknowledge that Swim-Inn has and will continue to take every possible precaution to keep Participant healthy. I represent that neither I nor Participant has a fever, has had a fever or been sick in the last ten (10) days; and I represent that no family member with which

Participant has come in contact has had any symptoms of Covid-19. I hereby promise to advise SwimInn of any changes should they occur.

6. I Hereby release, discharge, and covenant not to sue Swim-Inn, their respective administrators, directors, agents, officers, members, volunteers, and employees, owner and lessors of premises on which the Lessons take place, (each a “**Releasee**” collectively “**Releasees**” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the

Releasees or otherwise, including negligent rescue operations and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

Consent: I the undersigned parent or guardian/participant hereby grants authority to the staff at Swim-Inn to render a judgment concerning medical assistance or hospital care in the event of an accident or illness whether I am present or otherwise.
