**Setup Hours: Monday July 8<sup>th</sup>- Wednesday July 10<sup>th</sup>, 9 AM-7 PM.**

\*No setups prior to Monday 9 AM.

\*Booths must be setup and open by Opening Ceremony, Thursday, July 11<sup>th</sup> at 9 AM.

\*Must remain within the size of space paid for and assigned by Director of Vendors and Concessions  
(Additional frontage can be purchased prior to show opening if available)

**Show Hours of Operation: Thursday July 11<sup>th</sup> – Saturday July 13<sup>th</sup>, 9 AM- 8 PM,  
and Sunday, July 14<sup>th</sup>, 10 AM- 2PM.**

\*Booths must be open for business for the entirety of the show hours.

\*Indoor vendor building will be locked at 9 PM or when crowds have dispersed and will open at 8 AM.  
(Vendors may not force out anyone for closing. Only Director will close the building.)

\*NO EARLY TEARDOWNS.

\*Any vendor who leaves prior to show's end without Director's approval,  
forfeits previous space location for the next year's show.

\*No blocking of aisles, driveways or doors during show hours.  
(Indoor vendors must be out of building by 6 PM July 14<sup>th</sup>)

**NO FOOD OR DRINK CONCESSIONS TO BE SOLD IN VENDOR SPACES.**

\*No obscene materials of any kind, words, posters, clothing, signs, etc.

\*No drugs or drug paraphernalia of any kind, including medical marijuana or related accessories.  
-acceptable materials are based on Director's judgment.

\*All materials must be presented truthfully. No counterfeits.

**Pets must be registered in the Show Office upon arrival.** There is no fee for registration.

Pets must be restrained at all times. Pets MUST BE cleaned up after!

\*Vendors must comply with all fire and health regulations and correct any citations.

Failure to do so will result in removal from show grounds and forfeiture of all fees.
