The Lessee shall indemnify and save harmless the GFP, Inc. its officers, trustees, members, agents and employees, and the employees and the Darke County Agricultural Society against any and all loss, expenses, damage claims, injuries, cause of action, attorney's fees and court costs which may be sustained by
