Dear Aquatics Families,

We are excited to welcome you to a new session of swimming lessons. Please take some time to review the following rules and guidelines to provide the best learning experience and ensure your child's safety and health.

- All forms and waivers must be turned in before your first lesson or the swimmer will not be allowed in the pool. Payments must be made prior to the swimmer's first lesson either online or over the phone.
- Anyone entering the facility must complete our online symptom checklist prior to their arrival. This Entry Screening will be available on our website and sent out prior to arrival. Anyone experiencing any symptoms of illness must stay home.
- Anyone instructed to stay home following our screening, will receive a credit on your account for the next session. If you fail to show up for your scheduled class or are more than 20 minutes late, you will forfeit the class.
- Face masks must be worn at all times while on the pool deck. Masks may be removed before entering the water.
- Only one guardian per child will be allowed into the facility. Guardians can wait at a table (*I table per person*) or be allowed to wait in their car until 5 minutes prior to the swimmer's lesson ending.
- Swimmers must come to their lesson no earlier than 5 minutes before the lesson starts <u>and</u> swimmers must come already dressed. Changing rooms will only be available for <u>AFTER</u> the lesson.
- Parking or drop offs will <u>not</u> be allowed in the circular loop outside of the pool. The loop will be actively used and monitored for child care drop off and pickup. To park in the back lot, you should enter through the Pearl Street entrance. Cars exiting the center must exit through the Torrey Street exit only.
- Swim lessons will be organized in accordance with <u>state guidelines</u>. Bubbles and goggles will no longer be available for shared use. Additionally, other equipment will be rotated and sanitized between uses. You are welcome to bring your own goggles or bubbles to lessons.
- The swimmer must be signed in immediately upon arrival.
- Anything worn in the pool must be made of bathing suit material. Street clothes (E.g. t-shirts or basketball shorts) will **not** be allowed in the pool as the material can affect the water clarity.
- Do **NOT** allow your child in the water at any point without the supervision of a lifeguard. Please have them wait at the tables.
- In order to minimize distraction for the swimmers and maintain a safe environment, we ask that spectators remain quietly <u>seated</u> while in the pool area.
- If you would like to take pictures or videos, please make sure it is only your child, and not any other children or instructors. This is a Westfield Child Center Policy and must be enforced.
- Please do your best to clean up after yourself and your children.
- Once lessons have been completed and you have changed, please exit promptly through the door by the changing station.
