This warranty is only valid to the owner of the vehicle at the time of sale or to the shop doing the repair for the owner.

- **GLASS, CARBURETORS, S.R.S. AIR BAGS, BRAIN BOXES, AND ELECTRONIC MODULES ARE SOLD “AS IS” WITH NO WARRANTY.**
- **TIRES THAT DO NOT HOLD AIR WILL BE REPLACED IF RETURNED WITHIN (48 HOURS)**
- **ENGINES THAT KNOCK EXCESSIVELY OR DEVELOP EXCESSIVE BLOW-BY OR EXCESSIVE OIL CONSUMPTION WITHIN NINETY (90) DAYS AFTER THE DATE OF PURCHASE WILL BE REPAIRED, REPLACED, OR THE PURCHASE PRICE WILL BE REFUNDED AT BELTSVILLE AUTO RECYCLERS' OPTION. ACCESSORIES WHICH MAY COME ON AN ENGINE SUCH AS FUEL SYSTEMS, DISTRIBUTORS, ELECTRONIC COMPONENTS, MANIFOLDS AND WATER PUMPS ARE NOT WARRANTED. TIMING CHAINS, TIMING BELTS AND DAMAGE DUE TO THEIR FAILURE ARE NOT COVERED. WE REQUIRE THE BELT OR CHAIN BE REPLACED BEFORE INSTALLATION. EXTERNAL GASKETS & SEALS ARE NOT WARRANTED. THEY SHOULD BE INSPECTED AND REPLACED IF NECESSARY BEFORE INSTALLATION.**
- **TRANSMISSIONS THAT DO NOT PERFORM PROPERLY MUST BE DIAGNOSED BY A BELTSVILLE AUTO RECYCLERS APPROVED TRANSMISSION SPECIALIST BEFORE THEY ARE REMOVED FROM THE CAR, WARRANTY WORK IS PERFORMED OR A REFUND IS MADE. PROBLEMS CAUSED BY IMPROPER INSTALLATION WILL BE CORRECTED AT THE CUSTOMER'S EXPENSE.**
- **ENGINE AND TRANSMISSION COOLING SYSTEMS, INCLUDING TRANSMISSION LINES, MUST BE FLUSHED ACCORDING TO MANUFACTURER'S INSTRUCTIONS AND TSB'S AND CHECKED TO CONFIRM THAT THE COOLING CAPACITY MEETS OEM REQUIREMENTS. RELATED FILTERS, SEALS, THERMOSTAT, OIL OR FLUID MUST BE REPLACED WITH OEM EQUIVALENT UPON INSTALLATION.**
- **CYLINDER HEADS ARE WARRANTED NOT TO HAVE CRACKS OR TO BE WARPED WHEN PURCHASED. CAMS, VALVES AND LIFTERS ARE NOT WARRANTED.**
- **A/C SYSTEMS MUST BE FLUSHED TO REMOVE CONTAMINANTS AND A NEW FILTER AND DRYER INSTALLED BEFORE INSTALLING A BELTSVILLE AUTO RECYCLERS A/C COMPRESSOR.**
- **POWER STEERING AND BRAKE SYSTEMS MUST BE FLUSHED TO REMOVE CONTAMINANTS BEFORE INSTALLING RELATED BELTSVILLE AUTO RECYCLERS COMPONENTS.**
- **OTHER PARTS THAT FAIL WITHIN NINETY (90) DAYS AFTER THE DATE OF PURCHASE WILL BE REPAIRED, REPLACED, OR THE PURCHASE PRICE WILL BE REFUNDED AT BELTSVILLE AUTO RECYCLERS' OPTION.**
- **THIS LIMITED WARRANTY IS VOID IF ANY PART:**
 - (A) IS USED FOR ANY PURPOSE NOT INTENDED BY THE MANUFACTURER.
 - (B) IS IMPROPERLY MAINTAINED.
 - (C) IS DISASSEMBLED OR DAMAGED.
 - (D) IS OVERHEATED.
 - (E) IS NOT PROPERLY INSTALLED AND ADJUSTED IN A COMMERCIAL AUTOMOTIVE REPAIR FACILITY WITHIN 7 DAYS BY A TECHNICIAN WHO IS ASE CERTIFIED FOR THE PART TYPE PURCHASED.
 - (F) IS USED IN HIGH PERFORMANCE, OFF ROAD OR COMMERCIAL VEHICLES.
 - (G) IS PAID FOR WITH DEFICIENT FORM OF PAYMENT, PAYMENT IS STOPPED OR ACCOUNT IS NOT PAID IN FULL BY THE 15TH OF THE FOLLOWING MONTH.
