Subject: Emancipation Proclamation re: Child Sex Slavery, Rebellion and Treason

Dear Mr. President and Listed Courts and Agencies,

This letter presents a draft 'Emancipation Proclamation', modeled on the original, and dated for the President's first day back in office, Encl (1). It proclaims freedom for all persons and children held as sex slaves, as well as the prosecution and punishment of those government agencies and individuals involved in that crime, as well as in treason and rebellion.

As government law enforcement agencies have abused President Trump since 2015, evidence shows similar abuses against myself and this church since 2010, Encl (2), and that the motive for these abuses was to hide Planned Parenthood's crimes against children, Encl (3).

PP's latest charges are now being litigated in the above Courts – Civil Cause 202107164 and Criminal Cause 179057701010. In response, evidence is being presented of PP's crimes and the assistance to PP by agencies including the FBI, Harris County District Attorney and Precinct 1 Constable. Related investigations by the agencies listed above are on-going.

As the SCOTUS decisions imposing slavery (Dred Scott) and segregation (Plessy) necessitated government law enforcement agencies abuse citizens opposed to them, so it was with the SCOTUS decision imposing abortion (Roe v. Wade). But all three of those decisions are on the ash heap of history and no longer opposing God's design. The listed Courts and investigative agencies are encouraged that they are free of the former intimidation of Planned Parenthood and the agencies once forced to support them.

By the President of the United States of America:

A Proclamation to end Child Sex Slavery, Treason and Rebellion.

Whereas, on the twentieth day of January, in the year of our Lord two thousand and twenty-five, a proclamation was issued by the President of the United States, containing, among other things, the following, to wit:

"That on the twentieth day of January, in the year of our Lord two thousand and twenty-five, all persons, including children held as slaves within any of the United States, shall be then, thenceforward, and forever free; and the Executive Government of the United States, including the Armed Forces thereof, will recognize and maintain the freedom of such persons including children, and will do no act or acts to repress such persons, or any of them, in any efforts they or others may make for their actual freedom.

Now, therefore I, Donald J. Trump, President of the United States, by virtue of the power in me vested as Commander-in-Chief, of the Armed Forces of the United States in time of rebellion, treason and enslavement of persons, including children by any government or civilian agency or individuals against the authority and government of the United States, and as a fit and necessary war measure for suppressing said rebellion, treason and slavery, do, on this twentieth day of January, in the year of our Lord two thousand twenty-five, and in accordance with my purpose so to do publicly proclaimed and confirmed that all individuals engaged in such rebellion, treason and slavery, subject to prosecution and punishment under the laws of the United States.

And by virtue of the power, and for the purpose aforesaid, I do order and declare that all persons, including children held as slaves within the United States, are, and henceforward shall be free; and that the Executive government of the United States, including the Armed Forces thereof, will recognize and maintain the freedom of said persons, including children.

And I hereby enjoin upon the people so declared to be free to abstain from all violence, unless in necessary self-defense; and I recommend to them that, in all cases when allowed, they labor in faith in the process of Divine restoration.

And I further declare and make known, that such persons, including children, will be received initially and briefly as necessary for their protection into the armed service of the United States to garrison forts, positions, stations, and other places until restoration to their families or placed into God's loving arms under civilian care.


And upon this act, sincerely believed to be an act of justice, warranted by the Constitution, upon military necessity, I invoke the considerate judgment of mankind, and the gracious favor of Almighty God.

In witness whereof, I have hereunto set my hand and caused the seal of the United States to be affixed.

Done at the City of Washington, this twentieth day of January, in the year of our Lord two thousand and twenty-five, and of the Independence of the United States of America the two hundred forty-seventh.

My shofar sounds inside PP (construction site) - misdemeanor trespass charged. Harris County District Attorney assigns 4 prosecutors and requests jury trial. Prosectorial misconduct documented in transcripts and book, 'Horn of Samuel'.



DA expedites trial before Mayor cuts PP opening ribbon two months later.

March – April 2010: Shofar Sounds Inside PP (Construction Site). Conviction 2 Months Later, Before Mayor Cuts Opening Ribbon



PP Escort exits PP lot and knocks me down with his car. Witness calls 911 and HPD responds. Police report, witnesses, video, medical injury reports given to the same District Attorney that conducted the above prosecution. Response letter states, "insufficient evidence". No action taken against PP.



April 9, 2011: Assault by PP Escort using Car. Witnesses, Police and Medical Reports, Video – HCDA Review: Insufficient Evidence



While distributing brochures, PP Security Director calls HPD and walks out to have me arrested, handcuffed, taken into PP parking lot and baked in the squad car for an hour until collapsed onto the pavement, still in handcuffs. When another counselor arrived, the handcuffs were removed and an HFD ambulance called.



May 16, 2011: PP Directs Torture by HPD – Police Chief Refuses To Reprimand Officers Responsible



Thomas More Law Center files First Amendment Complaint against City and HPD re: May 16, 2011, torture and 2 other false arrests while evangelizing with my shofar downtown. I was also recording and posting YouTube videos about PP Crimes and officials involved.



May 15, 2013: TMLC files 1A Complaint (3 Arrests). City's Attempt to Quash Fails, TMLC Deposes HPD Police Chief



On May 16, 2011, the DA defined trespass as "crossing the fence line" - so I walked in the driveways for 3 years. Until, with no notice, PP Security Director and the County Constables assigned to her arrested me. An "FBI" prosecutor misled the jury, and promised that HPD Officer Trinh would testify he'd told me the trespass limits changed – later denied by Trinh.

March 5, 2014: Arrest by PP Constables, HPD Officer Trinh Prepped For False Testimony – Process Kills TMLC Complaint



The Memorials Church begins peaceful, outdoor worship in mid-2020, believing America's largest abortion clinic would become 'The Memorials Re-Birth Center' for the healing of countless parents grieving abortions. After 6 months, PP sued the church for an injunction against its worship. Ongoing PP attacks have all failed.



February 2021 – Present: PP Civil Lawsuit for Injunction Against Worship, Repeated Failures To Stop Worship



Exposed PP crimes and removed shrubs. County Constables assigned to PP (Violation TX Code 2273) arrest me, deny phone calls and attorney. Felony criminal charge (\$2,000 shrubs) Pre Trial Order imposes failed injunction requests.


