BOARD RESOLUTION NO. 2026-49

A RESOLUTION APPROVING THE DISBURSEMENT OF TWO THOUSAND EIGHT HUNDRED PESOS (₱2,800.00) FOR THE REPAIR AND RESTORATION OF ASSOCIATION PRINTER

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on May 2, 2026, with a quorum present and acting throughout, and duly considered the following matters, among others, approving the repair and restoration of association printer;

WHEREAS, the association's office printer, an Epson L6290, has been found defective due to damaged pump, roller pad, and ink pad, rendering the unit unserviceable and beyond economical repair;

WHEREAS, the Board acknowledges the necessity of maintaining a functional printer for the continuous operations and administrative services of the association;

WHEREAS, Ms. Rhea Mulingbayan, Treasurer of the Board of Directors, voluntarily donated her Epson L6190 printer to the association for office use, subject only to the replacement of its suction pump in order to restore the unit to working condition;


WHEREAS, the Board finds it practical, economical, and beneficial to the association to authorize the repair of the donated Epson L6190 printer instead of procuring a new printer unit;


WHEREAS, the estimated amount required for the replacement of the suction pump is two thousand eight hundred pesos (₱2,800.00), chargeable against the association's Other Income – Petty Cash, while labor and servicing shall be rendered free of charge;


WHEREAS, under Board Resolution No. 2026-11, all disbursements and expenses exceeding two thousand five hundred pesos (P2,500.00) require prior approval by the Board of Directors through a Board Resolution, and such approved disbursements may be paid through Petty Cash without the issuance of a check;


NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors, unanimously approves the disbursement of two thousand eight hundred pesos (₱2,800.00) for the repair and replacement of the suction pump of the donated Epson L6190 printer.


