BOARD RESOLUTION NO. 2025 – 69

A RESOLUTION APPROVING THE DISBURSEMENT OF THIRTY-TWO THOUSAND FOUR HUNDRED PESOS (P32,400.00) FOR THE PRINTING OF MONTHLY GARBAGE STICKERS FOR THE YEAR 2026

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of the Camella Lipa Homeowners' Association, Inc. convened in a virtual meeting on December 9, 2025, with a quorum present and acting throughout, and duly considered, among others, approving the disbursement of thirty-two thousand four hundred pesos (P32,400.00) for the printing of monthly garbage stickers for the year 2026;

WHEREAS, the Board of Directors adopted Board Resolution No. 2025-48, which amended the association's garbage sticker issuance policy from quarterly to monthly effective November 2025;

WHEREAS, the Board also adopted Board Resolution No. 2025-61, which reaffirmed and clarified that effective January 1, 2026, garbage stickers shall be issued only for the most recent month paid, and that issuance of stickers for prior or intervening months shall no longer be allowed;

WHEREAS, to ensure full implementation of the monthly sticker policy for Calendar Year 2026, the association requires the printing of 10,800 pieces of garbage stickers, equivalent to 900 pieces per month × 12 months with the following specifications:

- Sticker Size: 3 inches x 1.5 inches (3" x 1.5") vinyl and laminated
- Unit Price: Three Pesos (P3.00) per piece
- Total Cost: P32,400.00

WHEREAS, the said amount will be payable to DECAL WORLD PRINTING SERVICES;

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby approves the disbursement of thirty-two thousand four hundred pesos (P32,400.00) for the printing of monthly garbage stickers for Calendar Year 2026.
