BOARD RESOLUTION NO. 2025 – 64

A RESOLUTION APPROVING THE DISBURSEMENT OF FORTY THOUSAND PESOS (P40,000.00) AS A BUDGET FOR THE CLHOAI BOARD OF DIRECTORS ELECTION 2026

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors approves and authorizes the disbursement of forty thousand pesos (P40,000.00) as budget for the CLHOAI Board of Directors Election 2026.
