
WHEREAS, the Association's existing stock of printer ink has been fully exhausted, creating an immediate need to procure additional supplies to prevent disruption in office operations;

WHEREAS, the specified amount will be payable to RIZELL JOY U. FORTUJ, Finance Officer, and will be subject for liquidation;




