BOARD RESOLUTION NO. 2026-47

A RESOLUTION APPROVING THE TEMPORARY FUEL SUBSIDY FOR ASSOCIATION GARBAGE HAULING SERVICES

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on May 2, 2026, with a quorum present and acting throughout, and duly considered the following matters, among others, approving the temporary fuel subsidy for association garbage hauling services;

WHEREAS, Camella Lipa Homeowners' Association, Inc. engages the services of Lipa City Federation of Homeowners' Association, Inc. as its duly contracted service provider for garbage hauling;

WHEREAS, the contracted service provider has requested a fuel subsidy to partially offset increased operational costs attributable to fuel price escalation;


WHEREAS, the Board of Directors recognizes the continuing increase in fuel prices and, in consideration thereof, finds it reasonable, necessary, and in the best interest of the association to grant a temporary fuel subsidy in the amount of three hundred pesos (₱300.00) per trip to ensure the continuous and efficient delivery of hauling services;


WHEREAS, that this shall be valid for three (3) months from its effectivity date or until fuel prices normalize, whichever comes first, unless earlier modified, extended, or revoked by the Board through a duly approved resolution;


WHEREAS, the said fuel subsidy shall be charged as a separate billing item and payable to VIRGO J. BAD-ANG, President of LCFHOAI, subject to proper billing and documentation;

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby unanimously approves the grant of a temporary fuel subsidy in the amount of three hundred pesos (₱300.00) per trip in favor of the Lipa City Federation of Homeowners' Association, Inc.


