## BOARD RESOLUTION NO. 2025 – 68

### A RESOLUTION APPROVING THE DISBURSEMENT OF THIRTY-FIVE THOUSAND PESOS (P35,000.00) AS BUDGET FOR THE PRINTING OF CAR STICKERS FOR THE YEAR 2026

WHEREAS, the Camella Lipa Homeowners Association, Inc. (the "Association") is a duly organized homeowners' association governed by its By-Laws, Rules and Regulations, and other governing documents adopted by the Board of Directors;

WHEREAS, the Board of Directors of the Camella Lipa Homeowners' Association, Inc. convened in a virtual meeting on December 1, 2025, with a quorum present and acting throughout, and duly considered, among others, approving the disbursement of thirty-five thousand pesos (P35,000.00) as budget for the printing of car stickers for the year 2026;

WHEREAS, the Board recognizes the necessity of procuring new car stickers for all qualified and registered homeowners and vehicle holders for the Calendar Year 2026, consistent with established HOA security and registration policies;

WHEREAS, for Calendar Year 2026, HOA Office recommended the printing of official car stickers with the following specifications:

- Sticker Size: 2 inches x 2 inches (2" x 2")
- Unit Price: Twenty Pesos (P20.00) per piece
- Total Quantity: 1,750 pieces
- Total Cost: P35,000.00

NOW, THEREFORE, BE IT RESOLVED, that the Camella Lipa Homeowners' Association, Inc. through its Board of Directors hereby approves the disbursement of thirty-five thousand pesos (P35,000.00) to cover the expenses for the printing of official CLHOAI vehicle car stickers for the year 2026.
