BOARD RESOLUTION NO. 2026-28

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF FIVE THOUSAND SEVEN HUNDRED SIXTY PESOS (P5,760.00) FOR THE PURCHASE OF A TV MONITOR FOR CCTV OPERATIONS

WHEREAS, the association maintains a CCTV system as part of its security measures for monitoring and safeguarding residents and common areas;




