Re : Temporary Adjustment in Garbage Collection Schedule

Please be informed that effective **May 21, 2025**, the community's garbage collection schedule will be temporarily adjusted to **twice a week**, specifically **every Wednesday and Saturday starting at 7:30 AM onwards**.

This adjustment has been made following close monitoring of collection volume and frequency, which indicates that a twice-weekly schedule is currently sufficient to meet the needs of the community. This new schedule shall remain in effect until further notice.

### Important Reminders

To ensure efficient waste management and compliance with safety standards, we remind all residents that the following items are strictly prohibited from inclusion in regular garbage collection:

- Glass bottles, broken porcelains, ceramics
- Construction and debris waste
- Hazardous waste (e.g., chemicals, batteries, paints)
- Medical waste (e.g., syringes, masks, test kits)
- Furniture and other bulky items
- Tree branches and large garden waste

Improper disposal of these materials may result in **delays in collection, health and safety hazards**, and possible **penalties** in accordance with the Association's waste management policies.

### Recyclables Collection Schedule

Recyclable materials shall continue to be collected **every Tuesday and Friday at 8:00 AM**. Please ensure that recyclables are properly segregated.
