BOARD RESOLUTION NO. 2026-34

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF TWO THOUSAND FIVE HUNDRED PESOS (P2,500.00) FOR THE PROCUREMENT OF UMBRELLA FOR TEMPORARY USE AT THE SWIMMING POOL AREA

WHEREAS, the Board of Directors of Camella Lipa Homeowners' Association, Inc. convened in a face-to-face meeting on March 28, 2026, with a quorum present and acting throughout, and duly considered the following matters, among others, authorizing the disbursement of two thousand five hundred pesos (P2,500.00) for the procurement of umbrella for temporary use at the swimming pool area;


WHEREAS, the existing tent installed at the swimming pool area, which is also being utilized by personnel for the registration and monitoring of homeowners and guests, is currently defective and no longer fit for safe and continued use, and is subject for repair or replacement;


WHEREAS, the Board has determined that the procurement of umbrella is a necessary and cost-effective temporary solution pending repair or replacement of the said tent;


